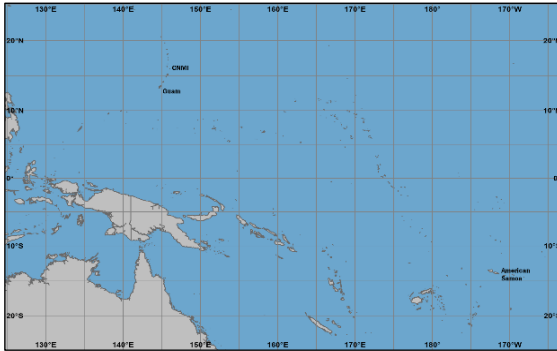

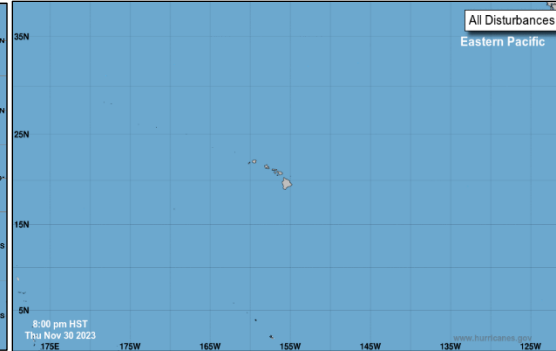

## Western Pacific



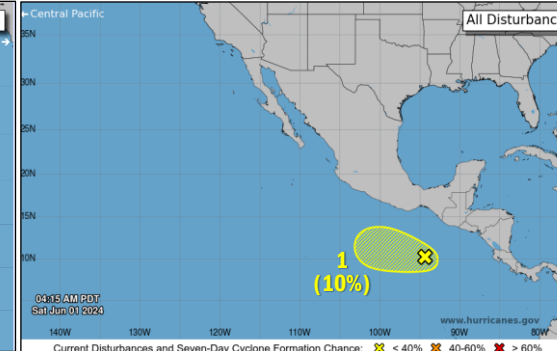
- No areas of concern for Guam, Commonwealth of Northern Mariana Islands or American Samoa

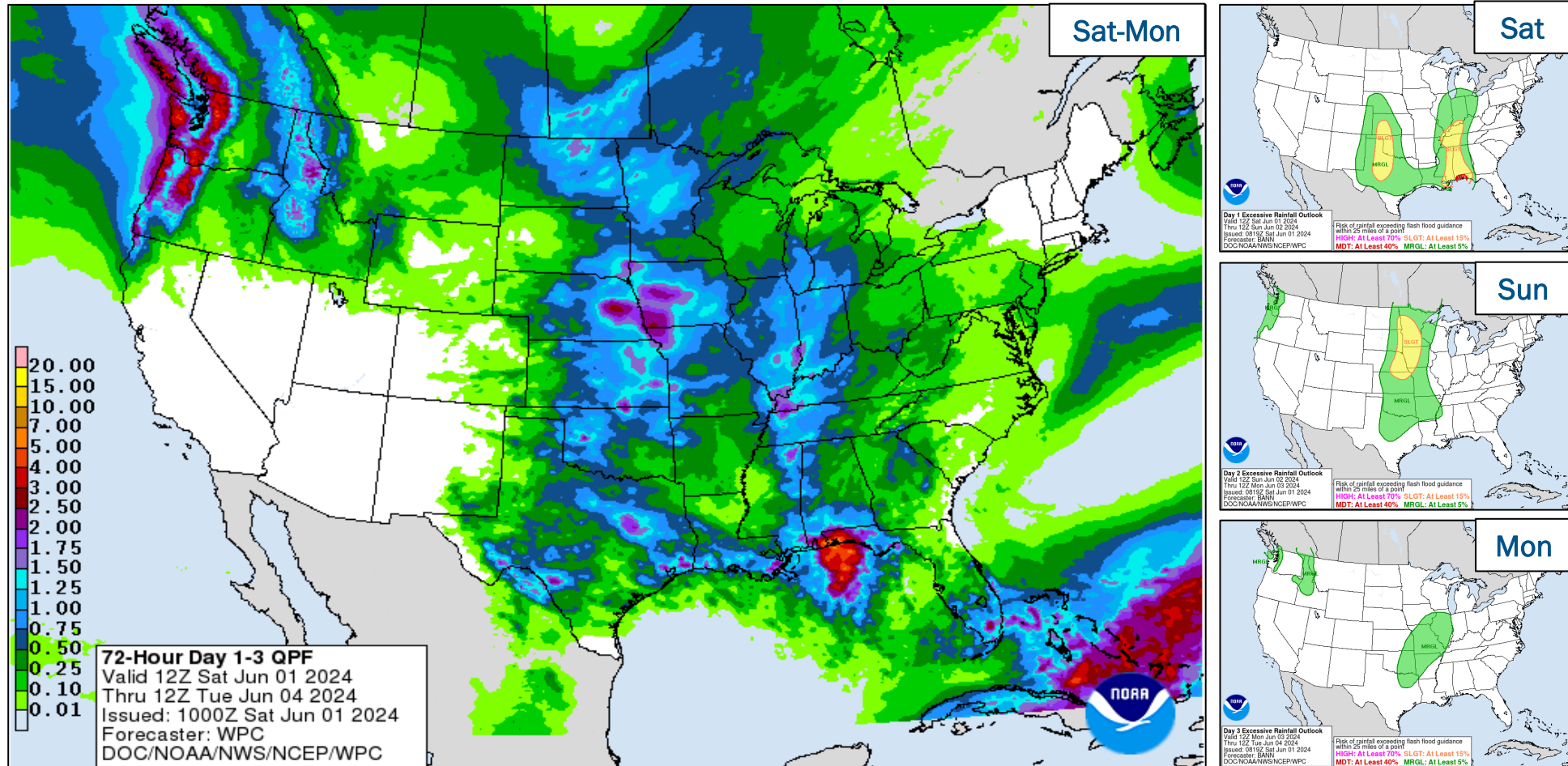
# Severe Weather Outlook

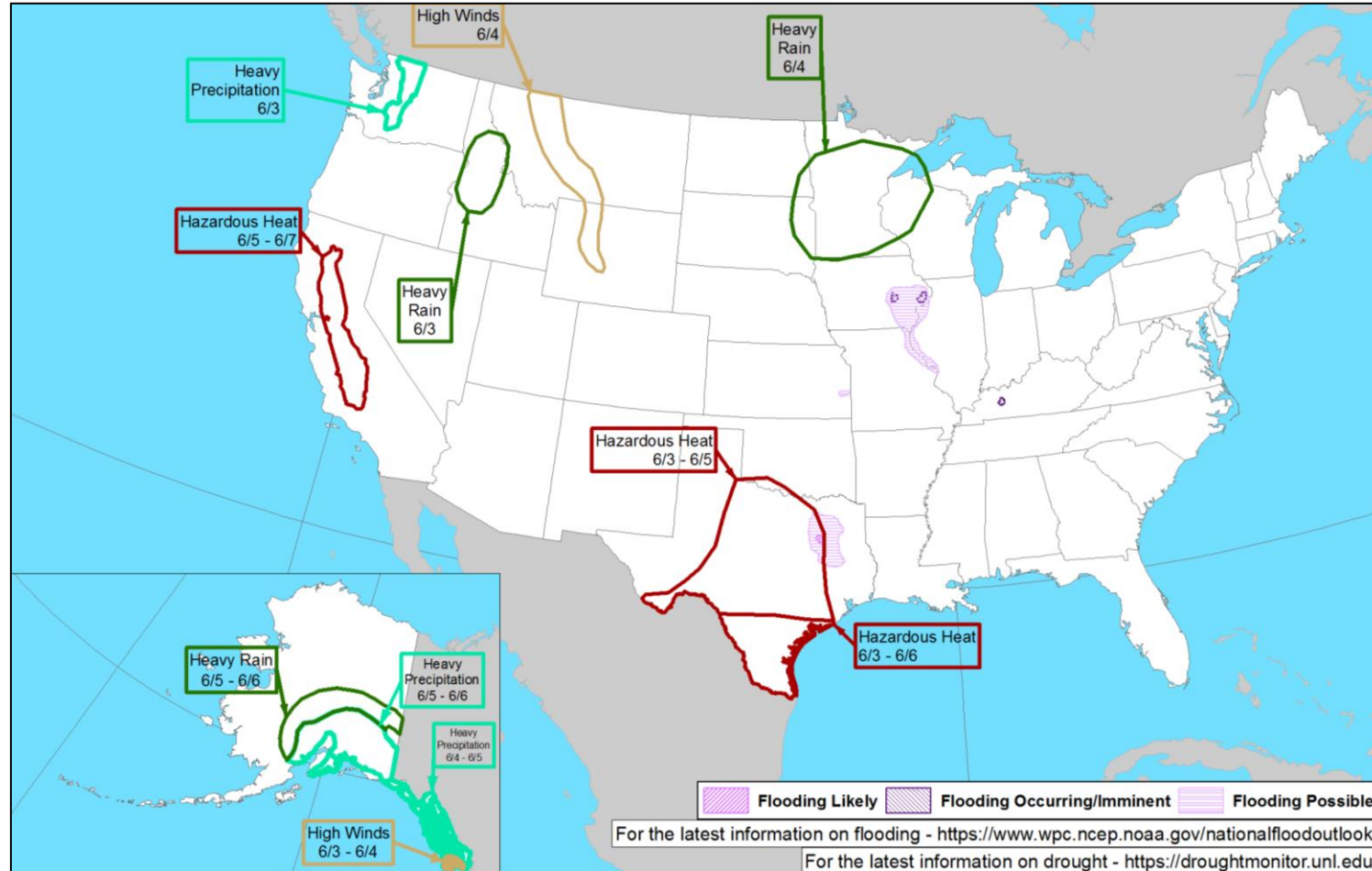
# Precipitation & Excessive Rainfall

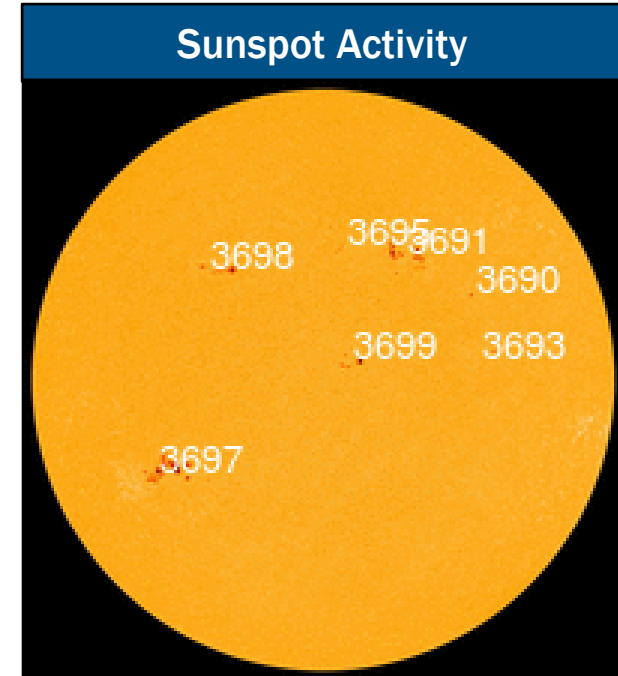
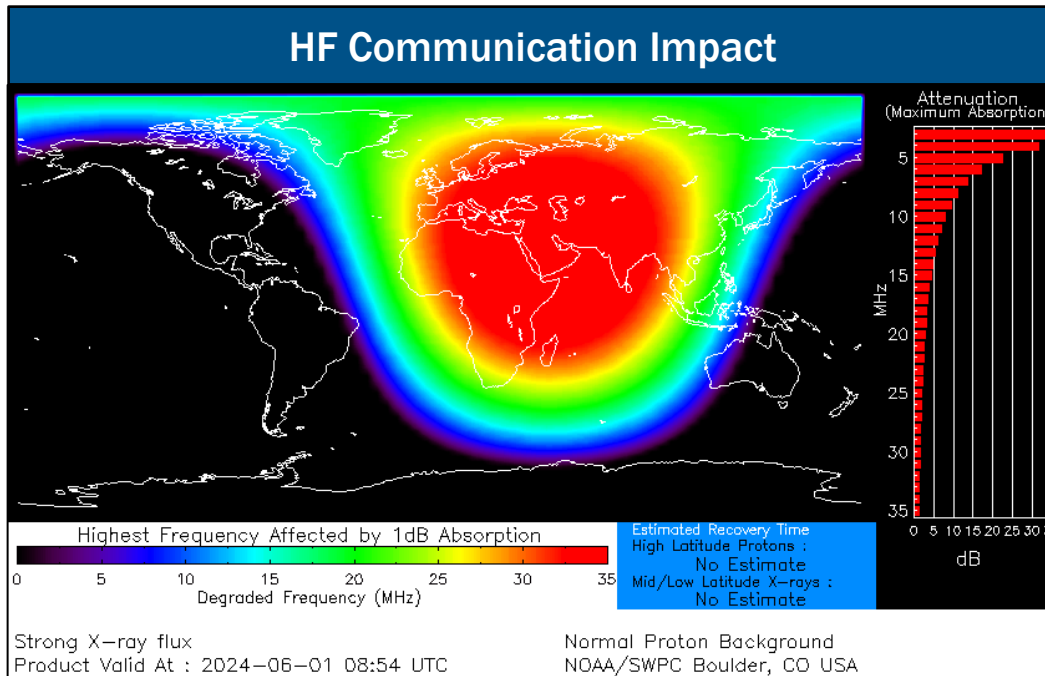

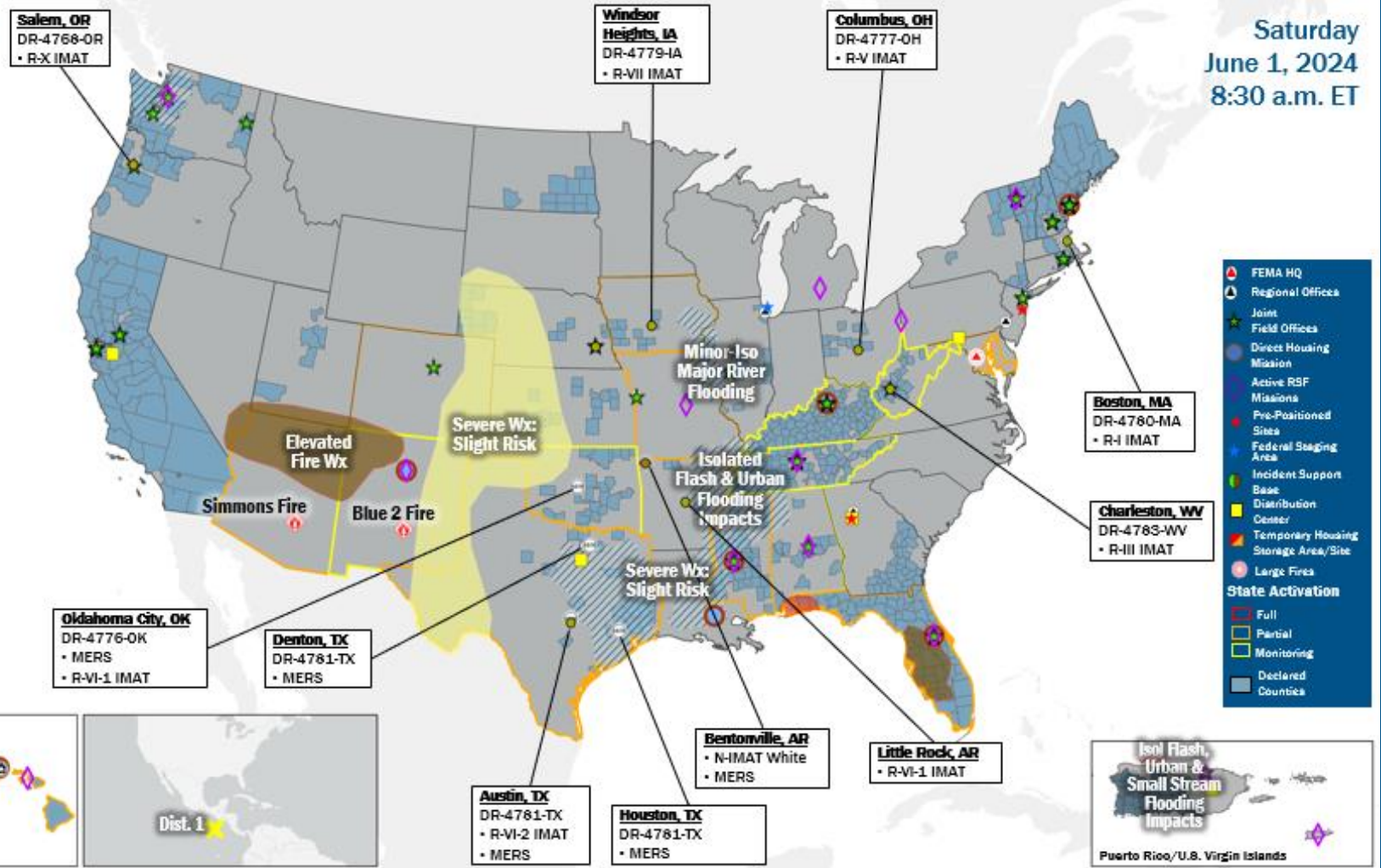
