




National Weather Forecast






Forecast Snowfall



FEMA Common Operating Picture



INCIDENT SUMMARY

On September 08, 2021, a Major Disaster Declaration was approved for the State of North Carolina, authorizing Individual Assistance for three (3) counties, and Public Assistance Categories A -G for seven (7) counties, with Hazard Mitigation available statewide. Amendment #1 added Public Assistance for four (4) counties.





Recovery Outcomes

HOUSING: Adequate, resilient, accessible and affordable housing

Outcome Indicators (1): All survivors whose primary residences were damaged or destroyed or were displaced by the disaster have returned and re-established residence in permanent housing within the affected community.

Initial Situation

- Local housing shortage
- 94 survivors in non-congregate shelters post-disaster
- Extensive discussions with State on solutions

Mustang Alley

- Challenges
 - 15 flood-damaged mobile homes
 - Initial request for commercial property debris removal denied
 - Uninsured
- Actions
 - State proposed alternative solution
 - FEMA reimbursement of commercial debris removal allowed below-market rental
 - The State in partnership with a local faith-based organization provided trailers
- Outcomes
 - Public, private, and faith-based organization partnerships resulted in a creative solution
 - As of December 14th, ALL survivors have transitioned out of non-congregate shelters

INFRASTRUCTURE: Houses of Worship Outreach Initiative

Outcome Indicator (5): Government and PNP facilities have been repaired, modernized, and strengthened for future disasters

Challenges

- Local experience in Public Assistance was limited
- Opportunity for equity-focused PA mission


Actions

- Working with local partners to identify houses of worship, ministerial associations, and community organizations/PNPs to target for outreach
- Reached out to 1600+ houses of worship and provided info on PA program application process
- Supported 3 virtual informational meetings with State, SBA, and FEMA to provide additional information to potential applicants

7 Houses of Worship from impacted areas applied for assistance following efforts
