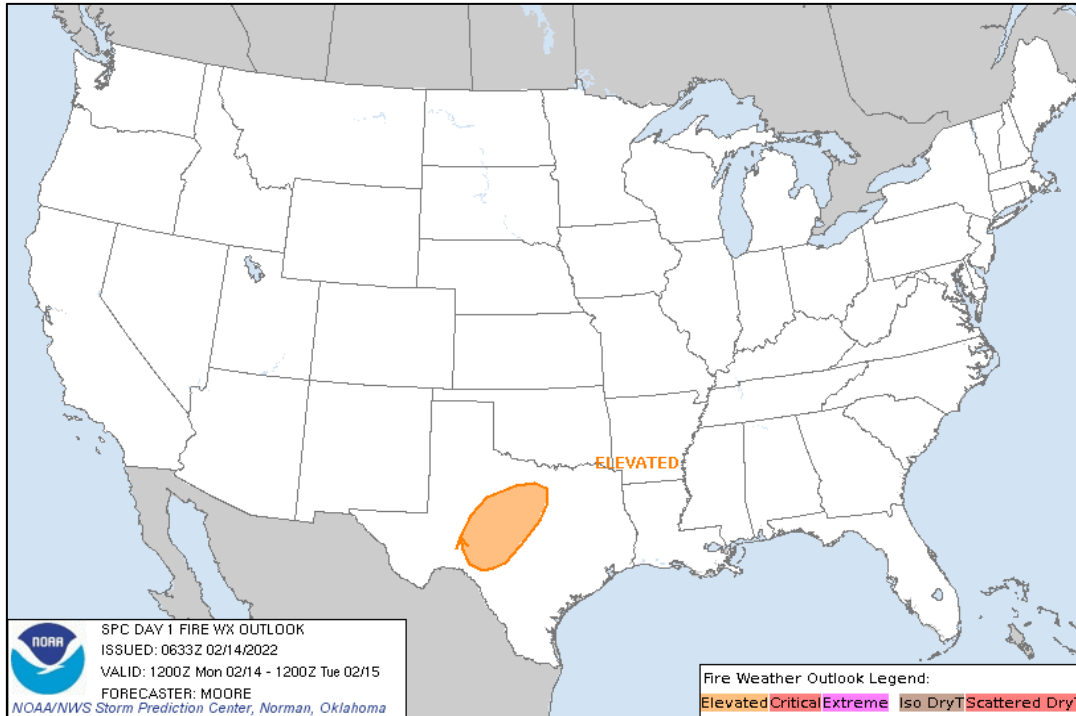
# Severe Weather Outlook



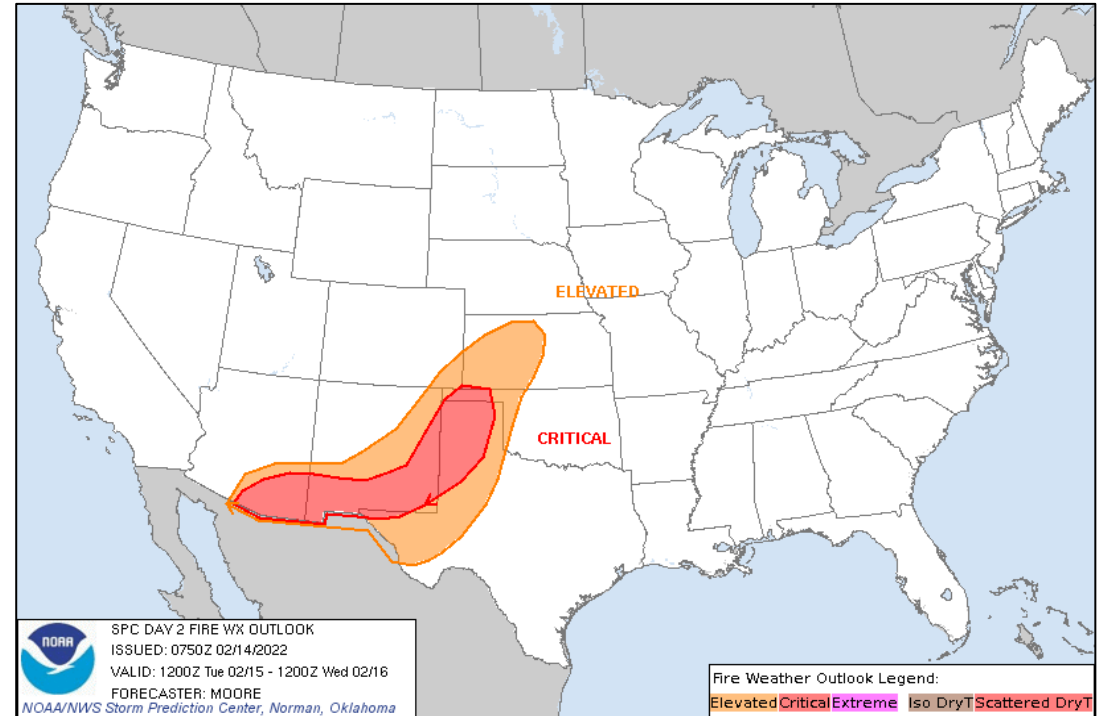

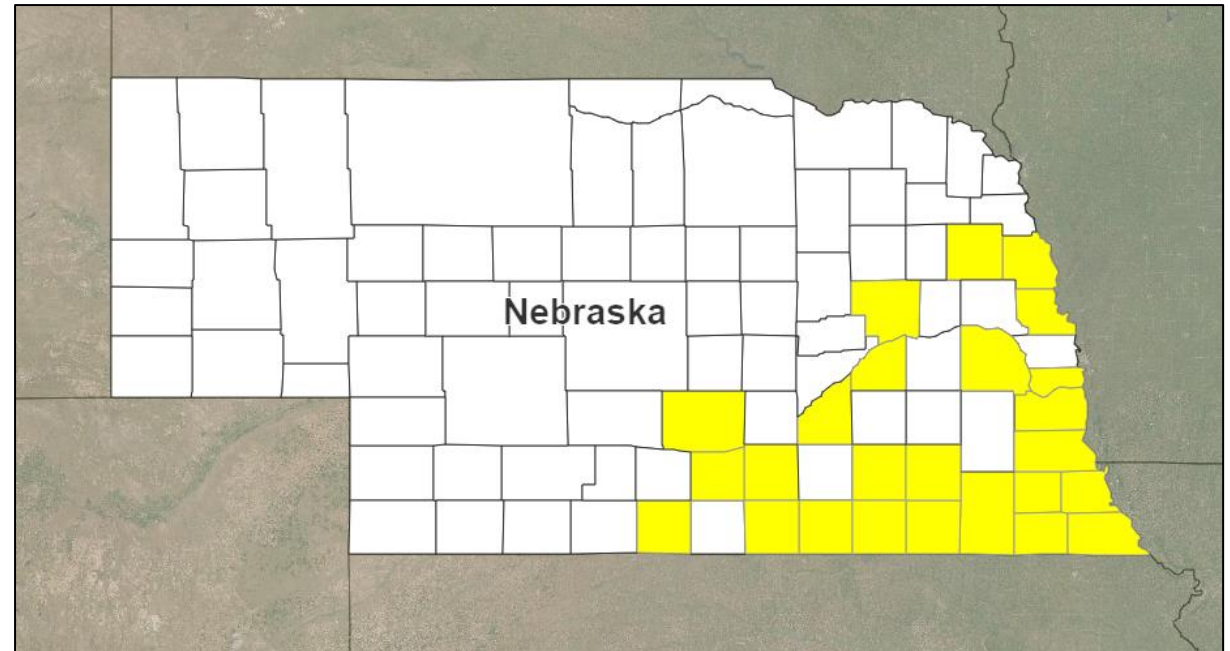

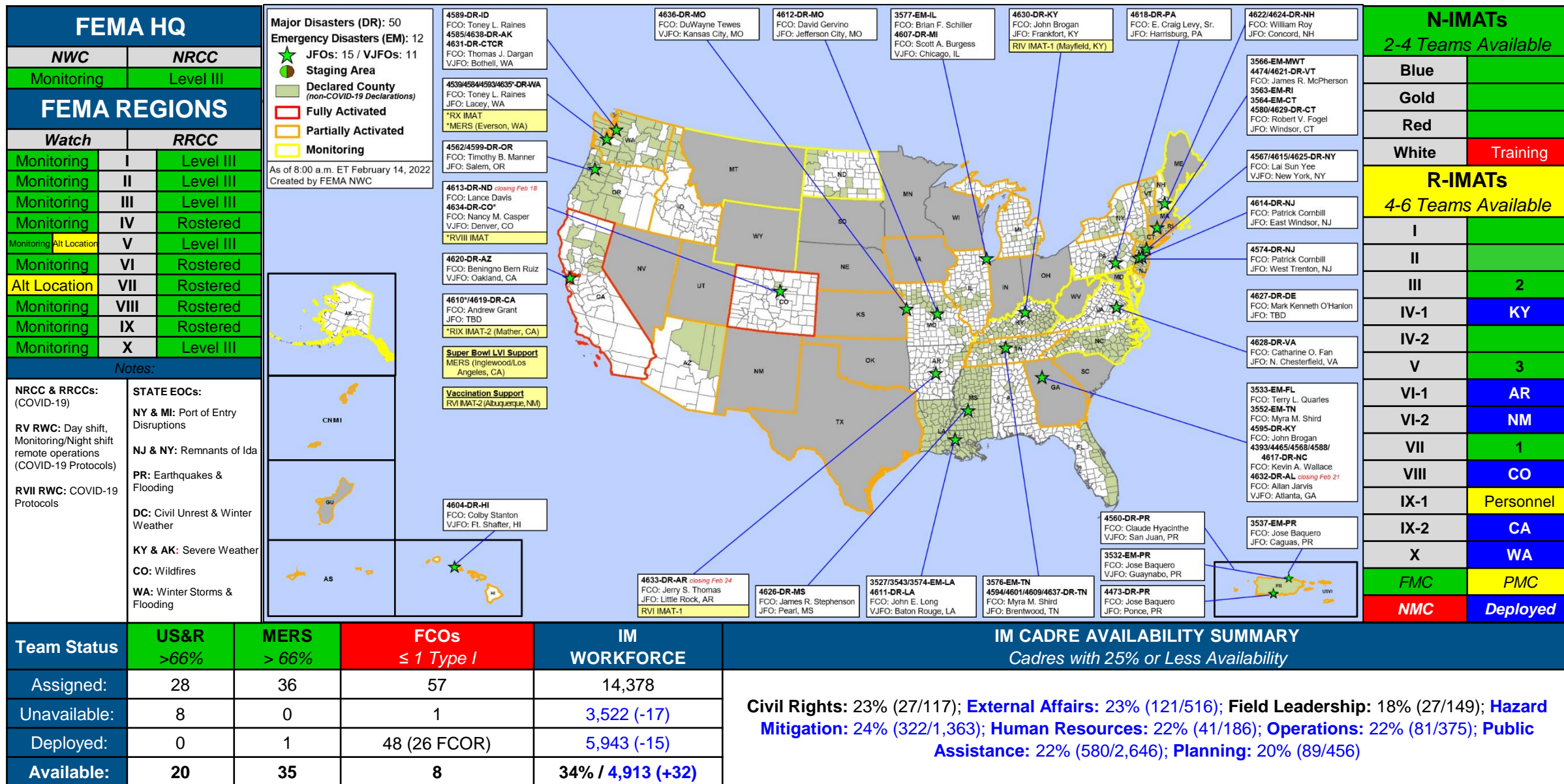
