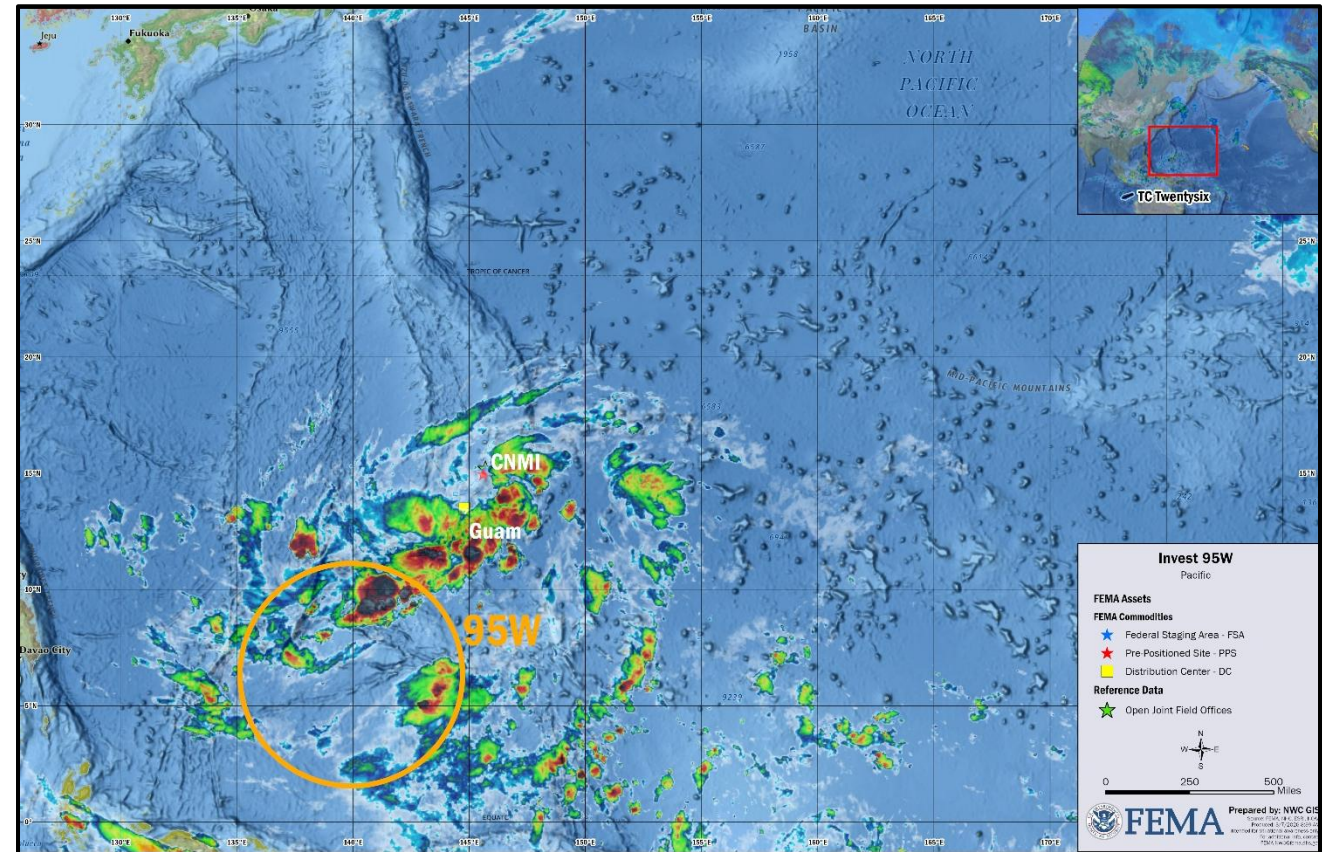
Western Pacific – Invest 95W

Invest 95W: *(Joint Typhoon Warning Center, as of 1:00 a.m. ET, Mar 7)*

- Located **188 miles SE of Yap**
- Maximum sustained winds **20-26 mph**
- Tracking near the Marianas Islands over the next 24-48 hours
- Medium chance of development for the next 24 hours

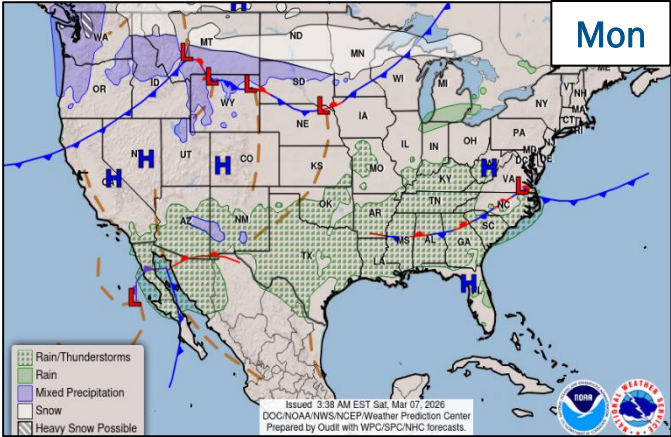
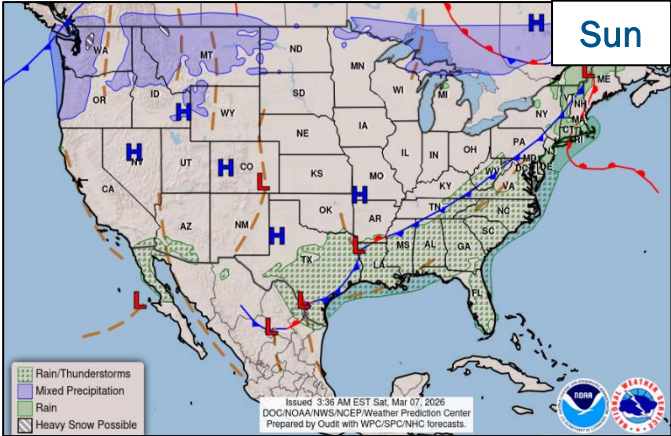
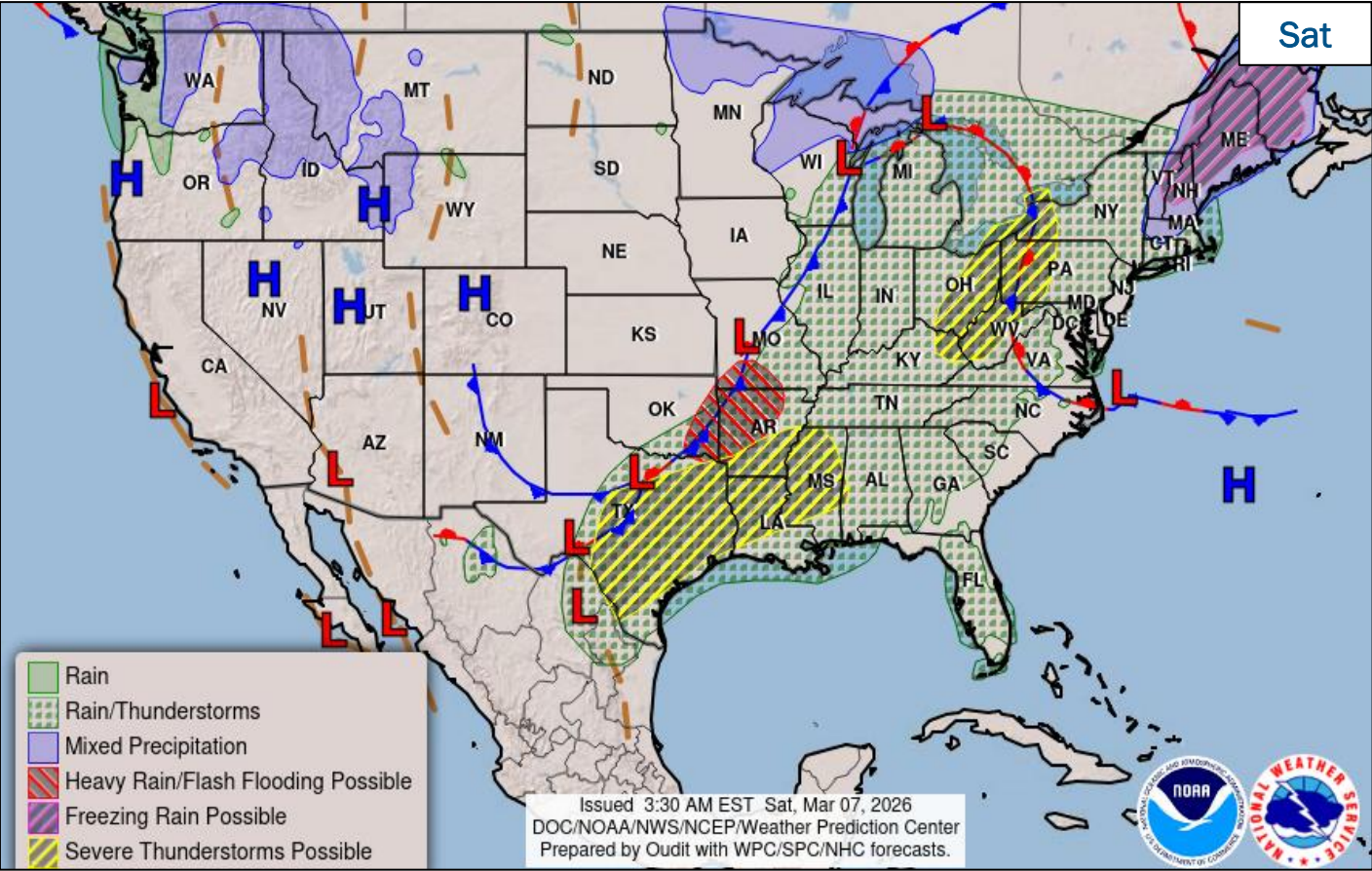
Potential Impacts:

- **4 to 8 inches** of rain are expected across the Marianas with locally higher amounts
- Excessive runoff may result in flooding of rivers, creeks, streams and other low-lying and flood prone locations

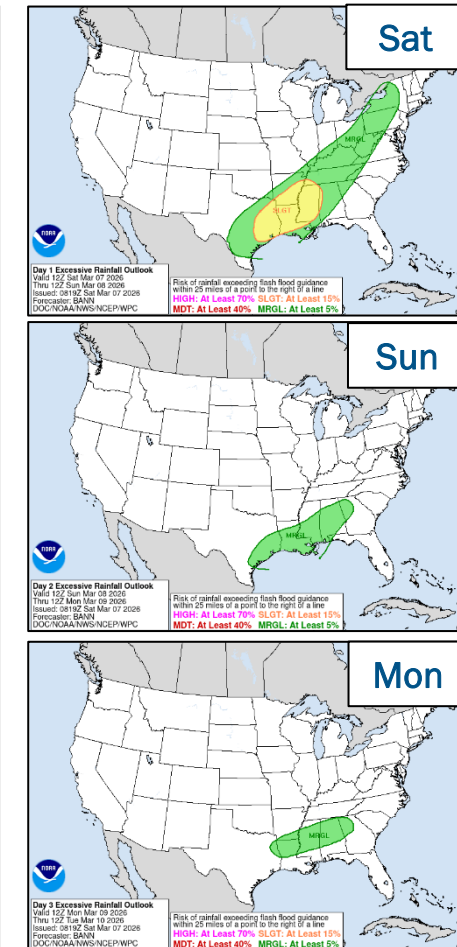
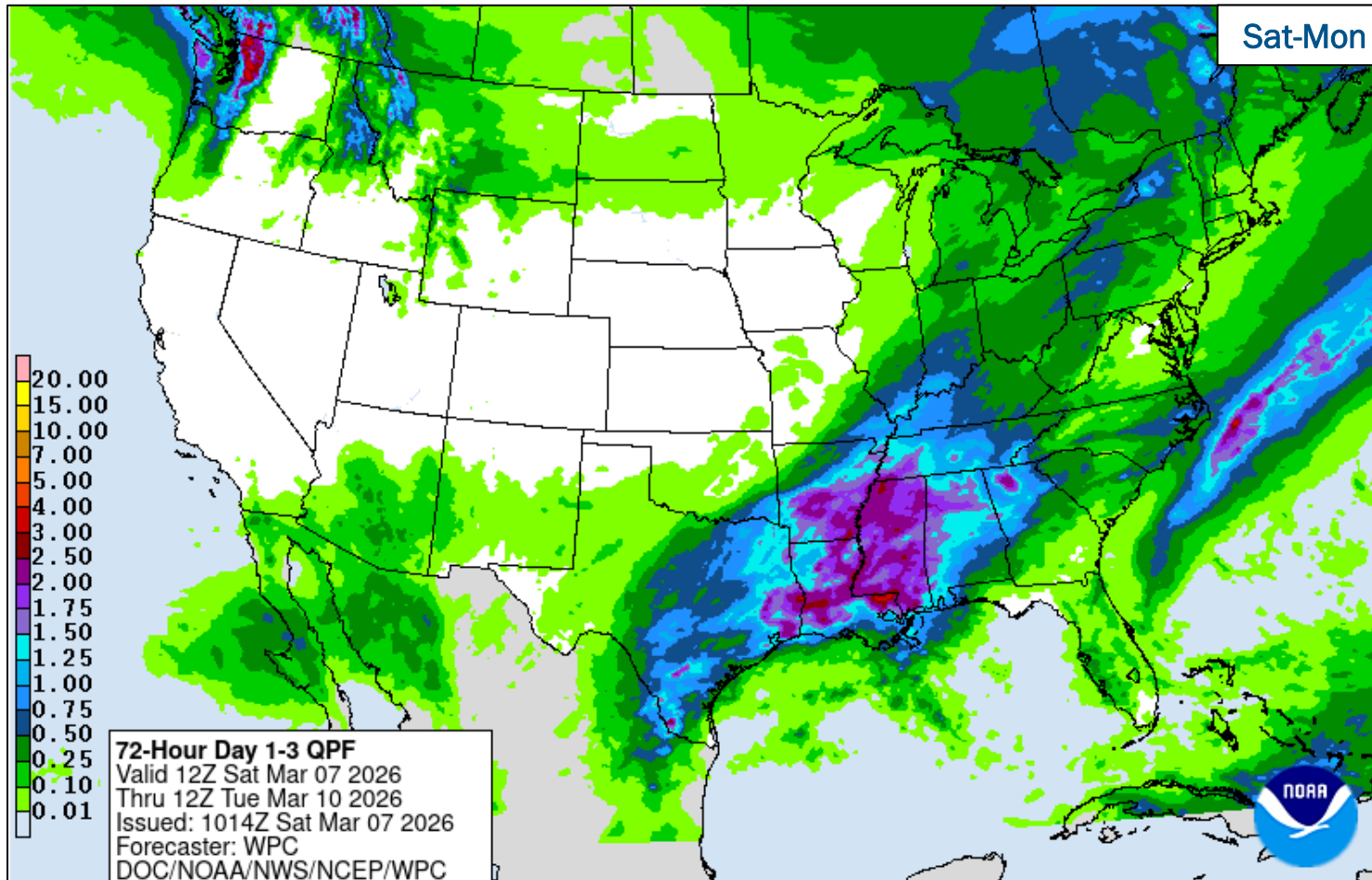

National Weather Forecast



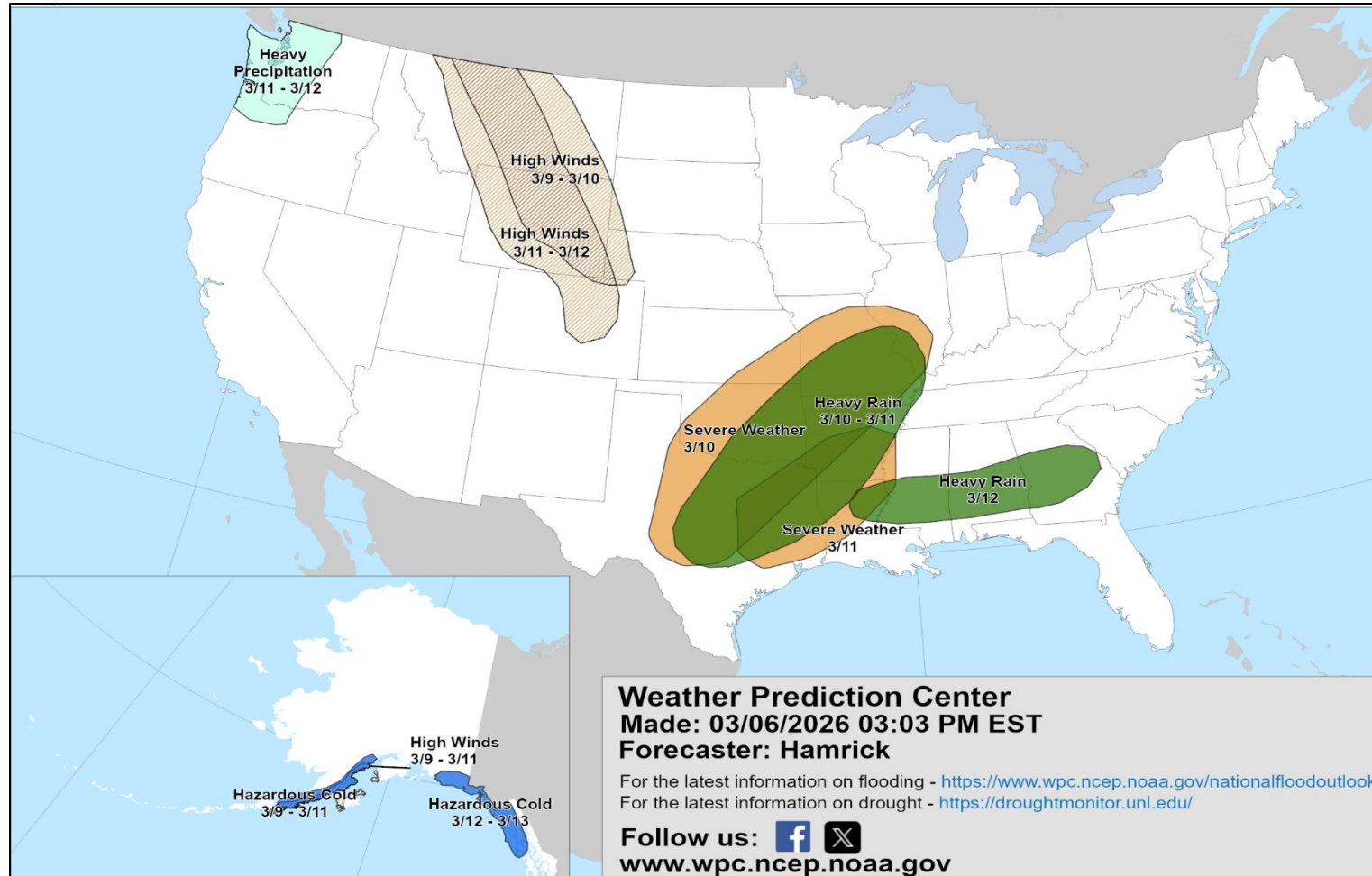
Precipitation & Excessive Rainfall

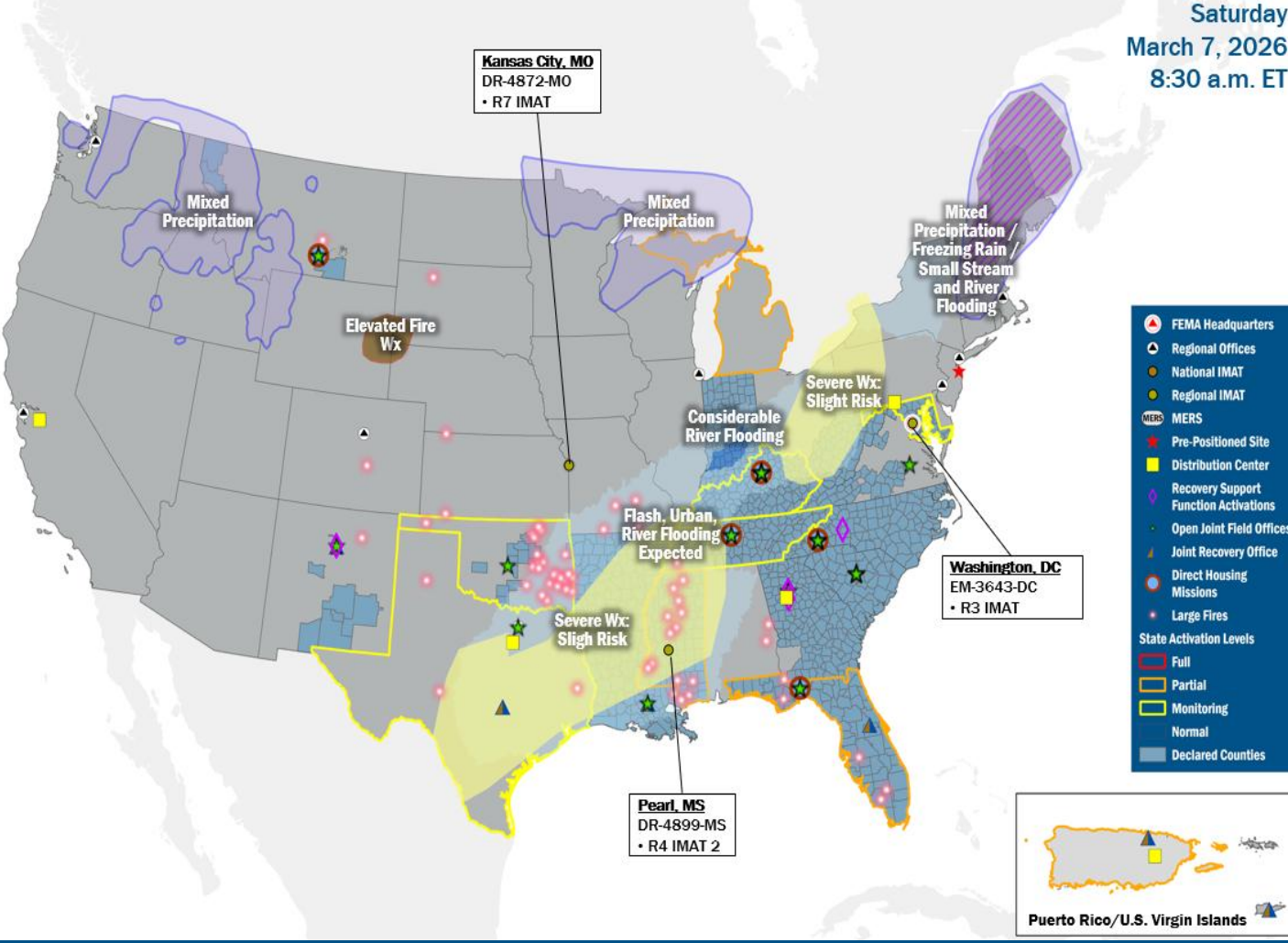
