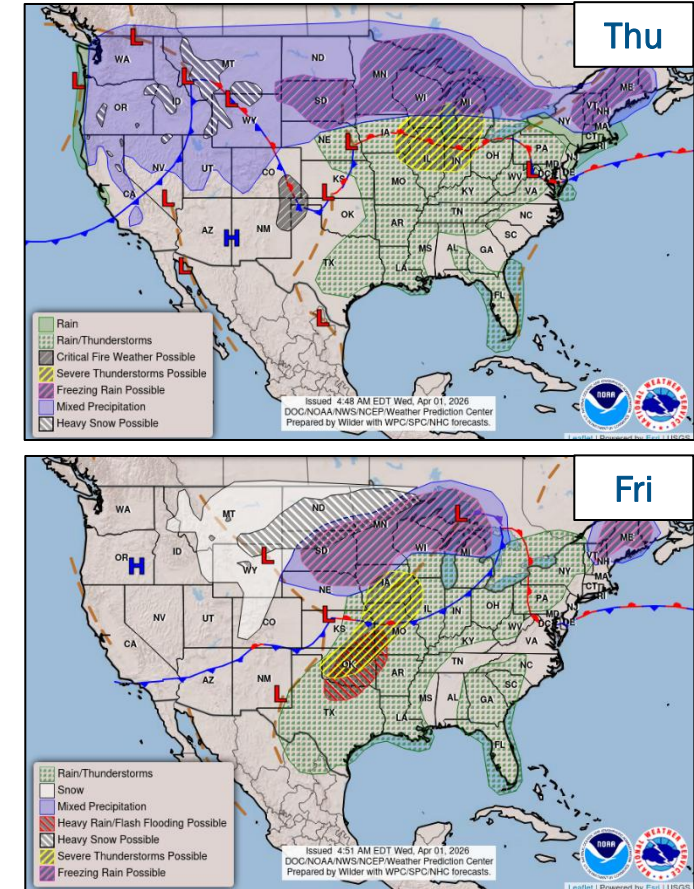

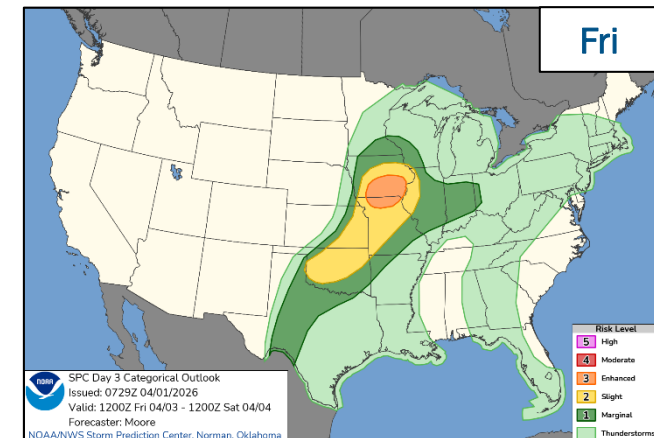

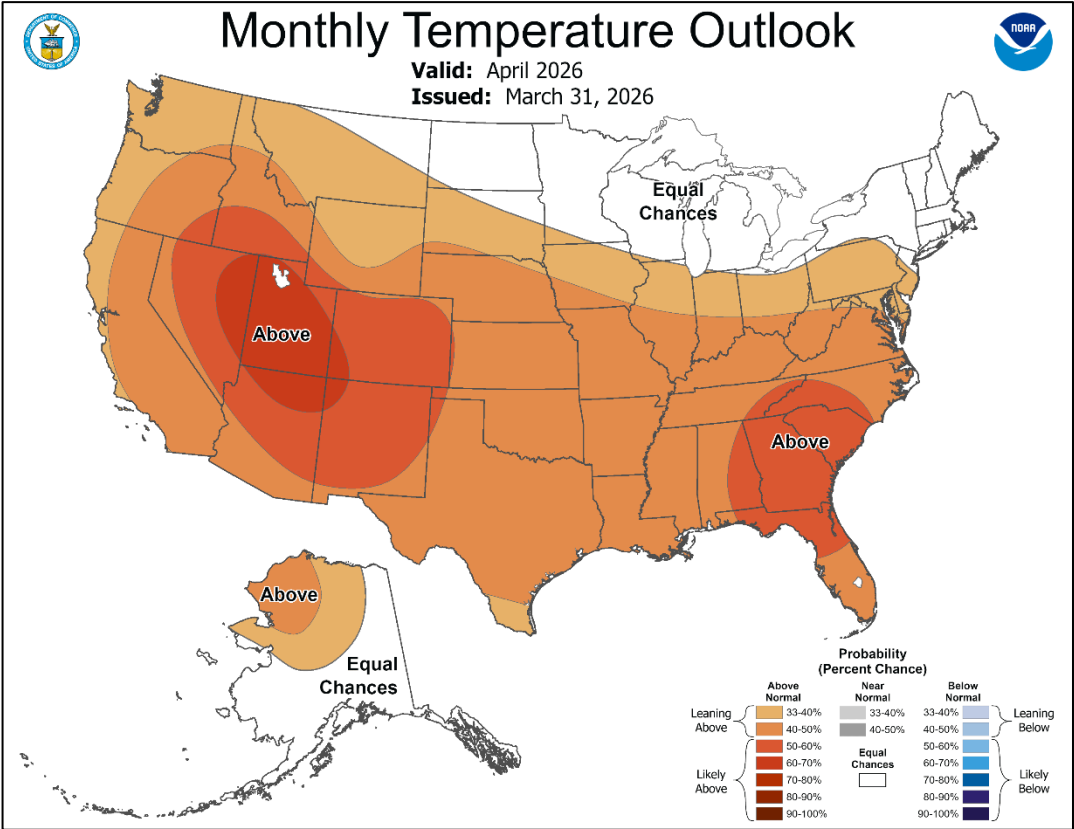
Severe Weather Outlook



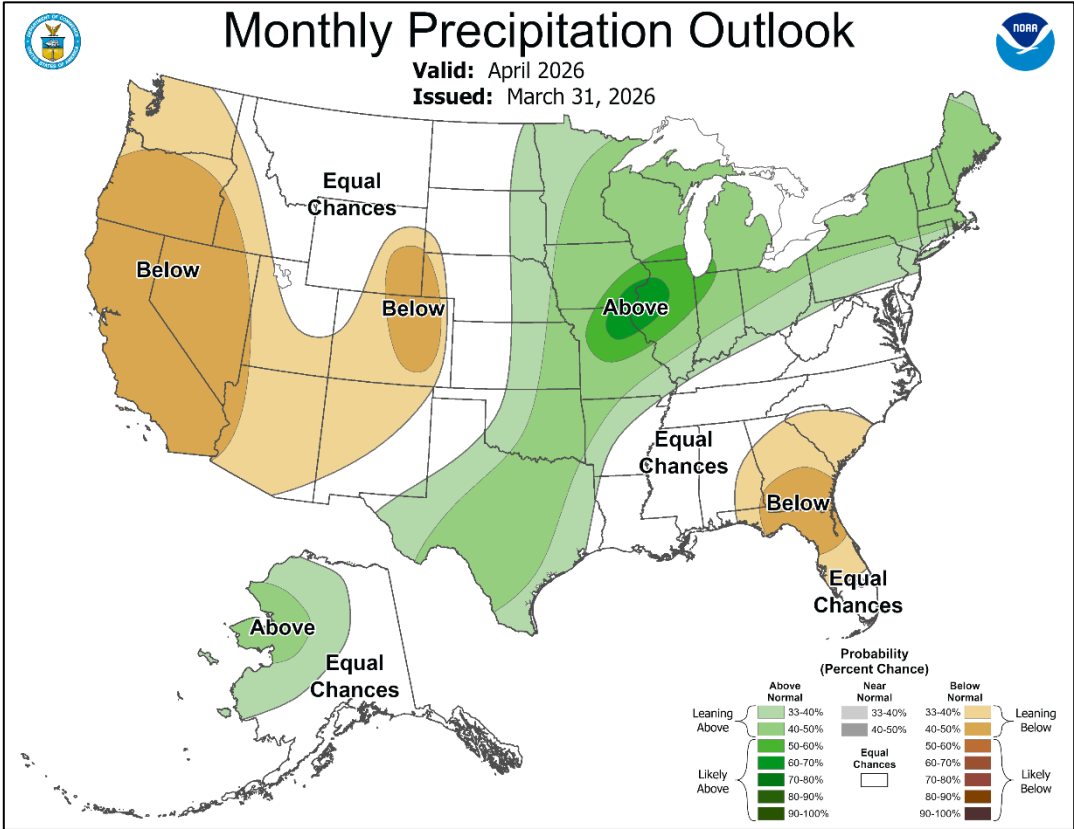

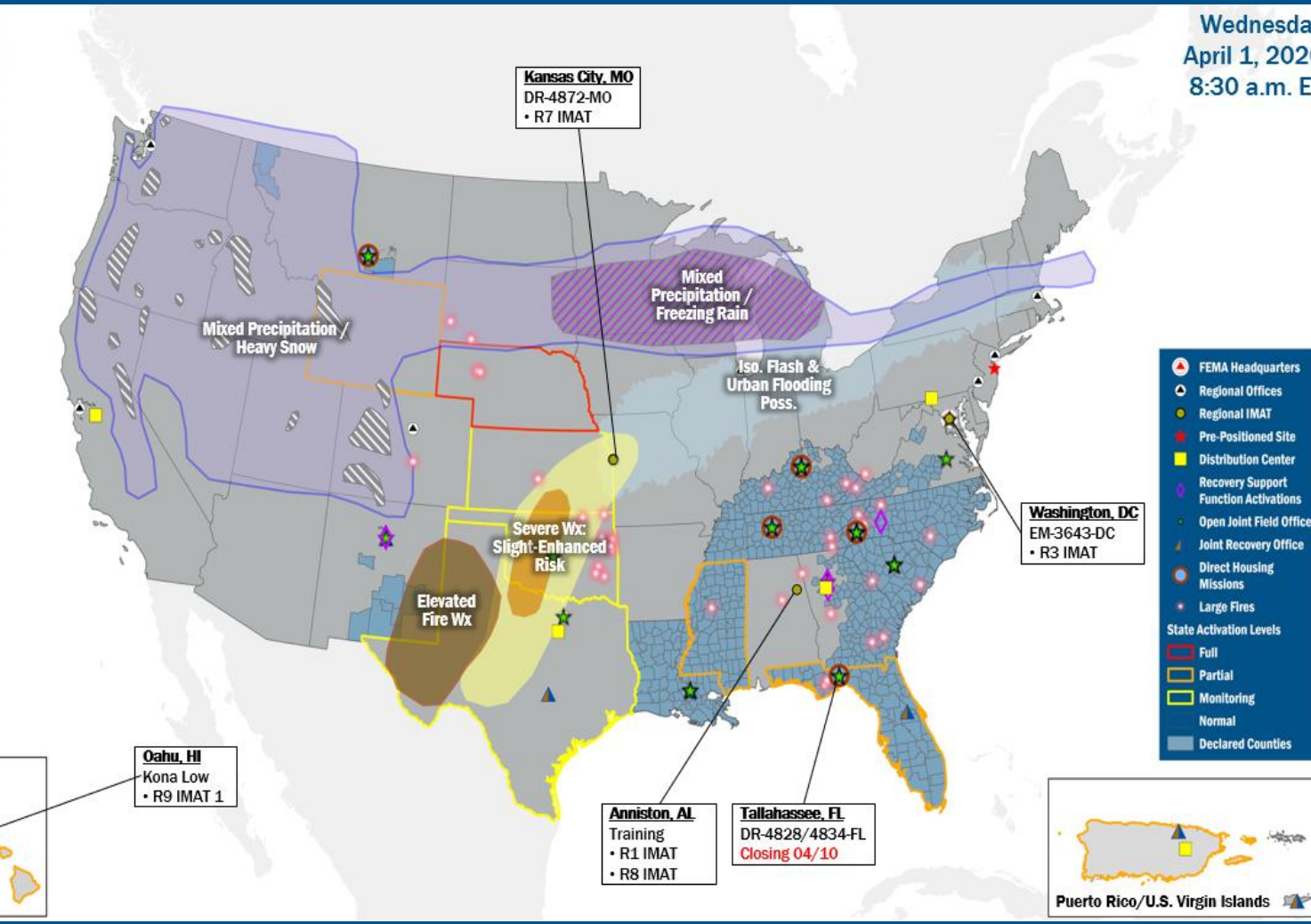
