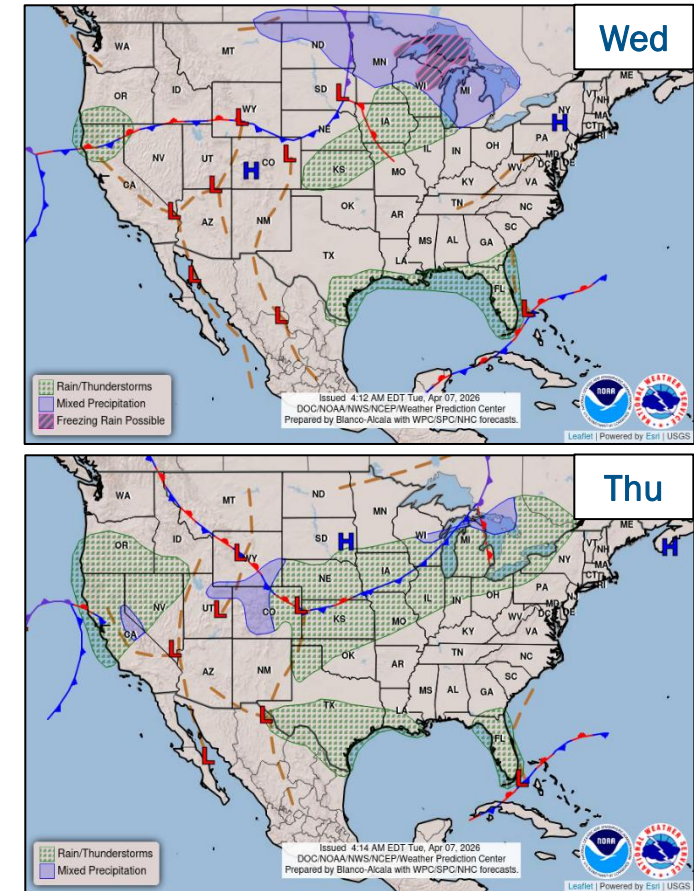
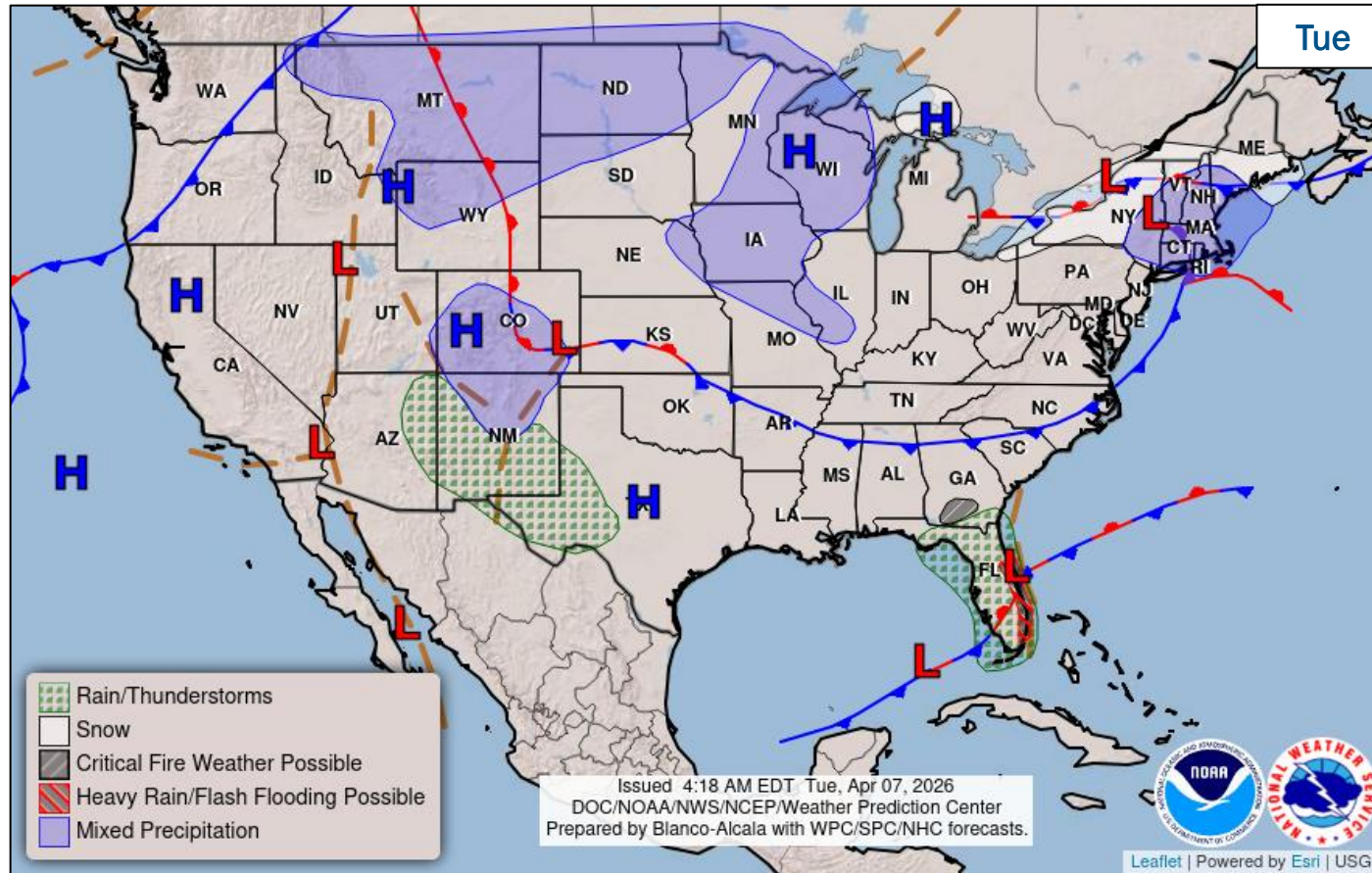

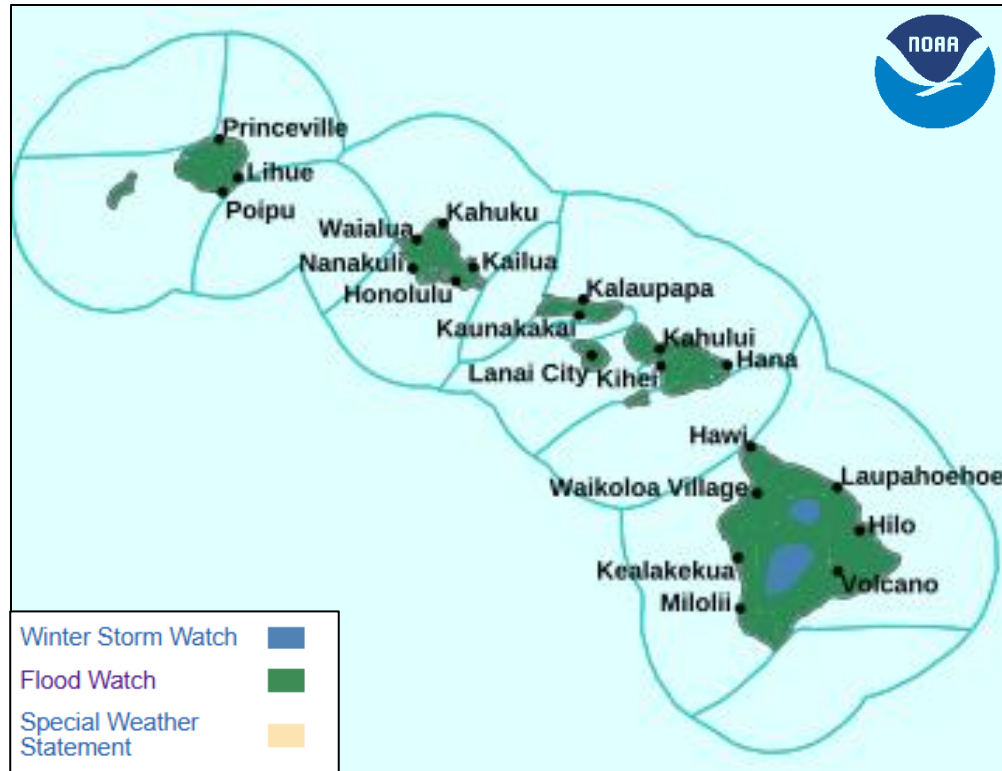
National Weather Forecast



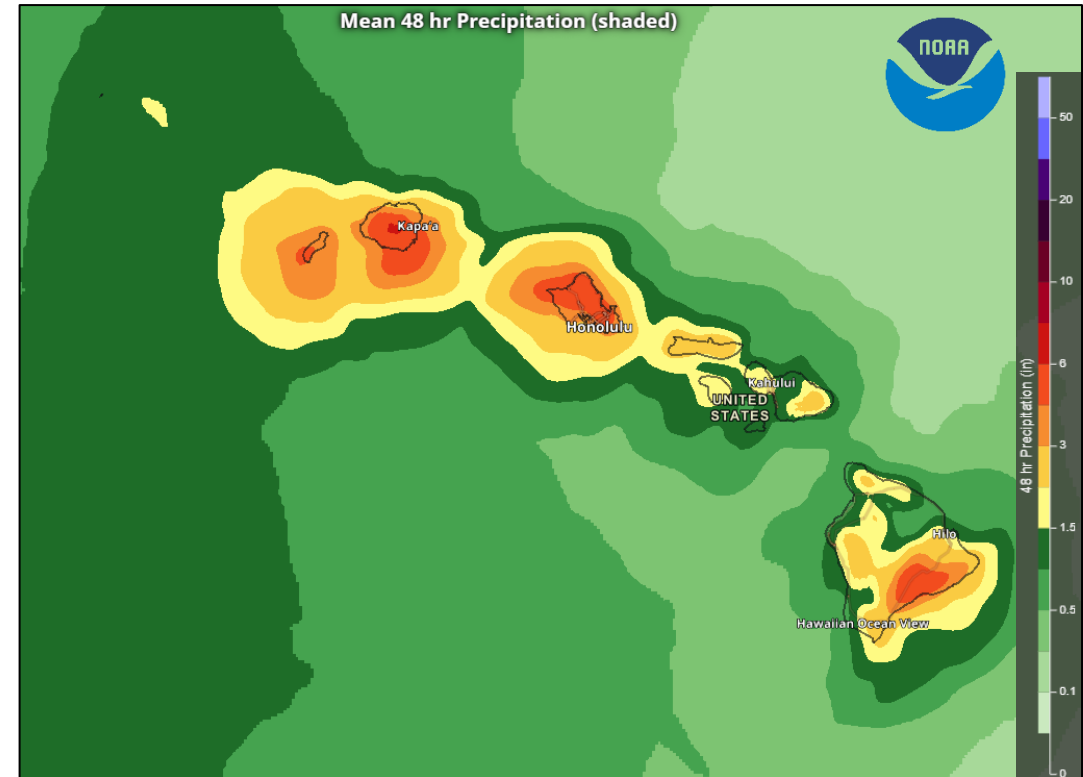

48-Hour Rainfall Forecast

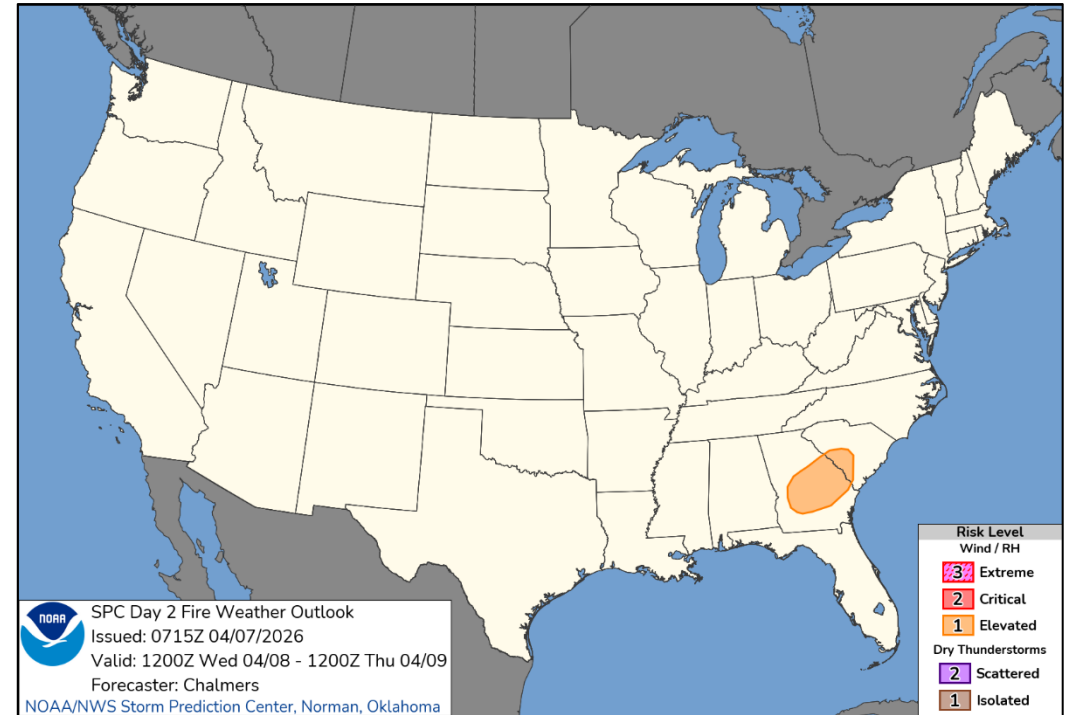

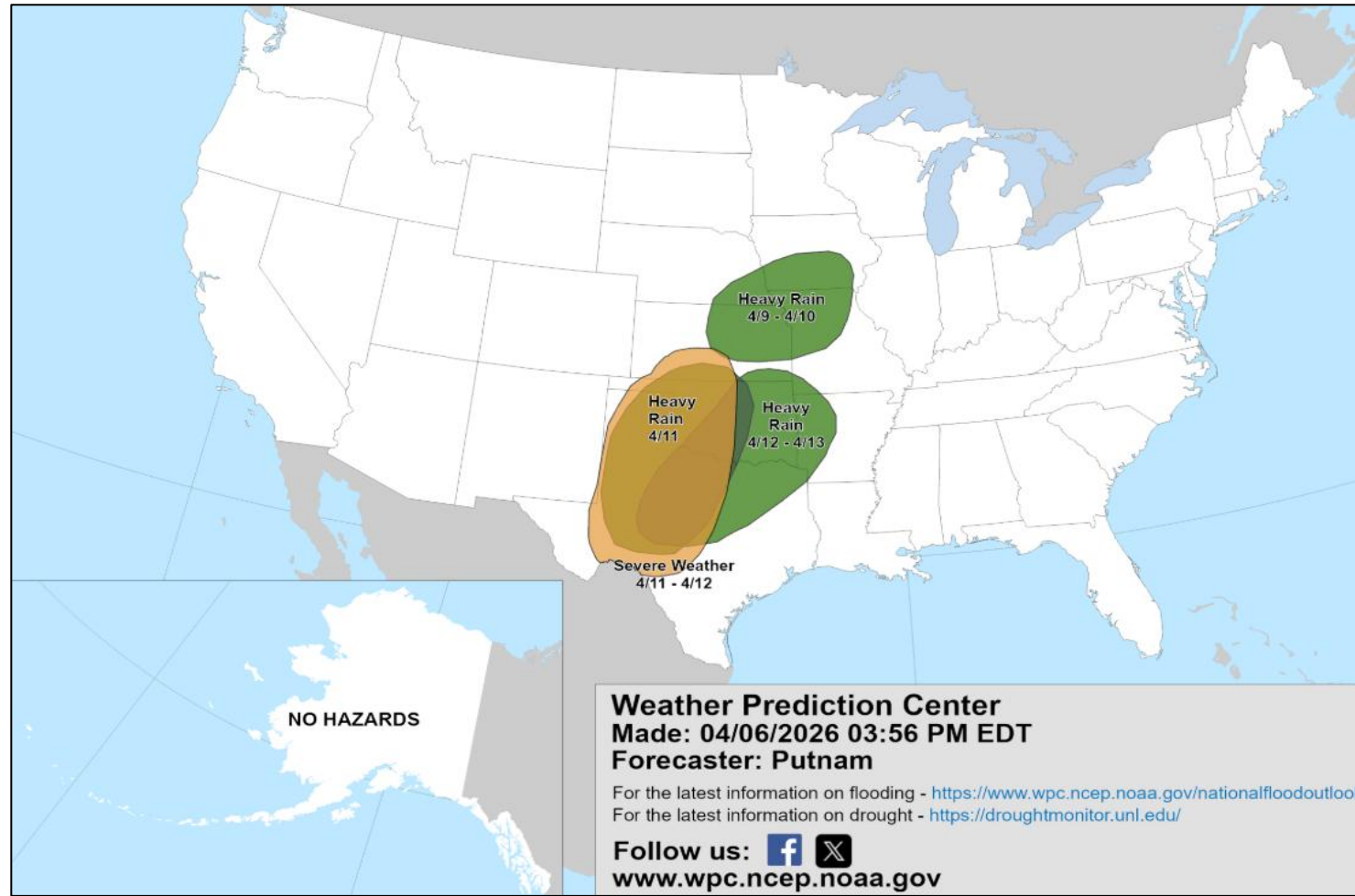

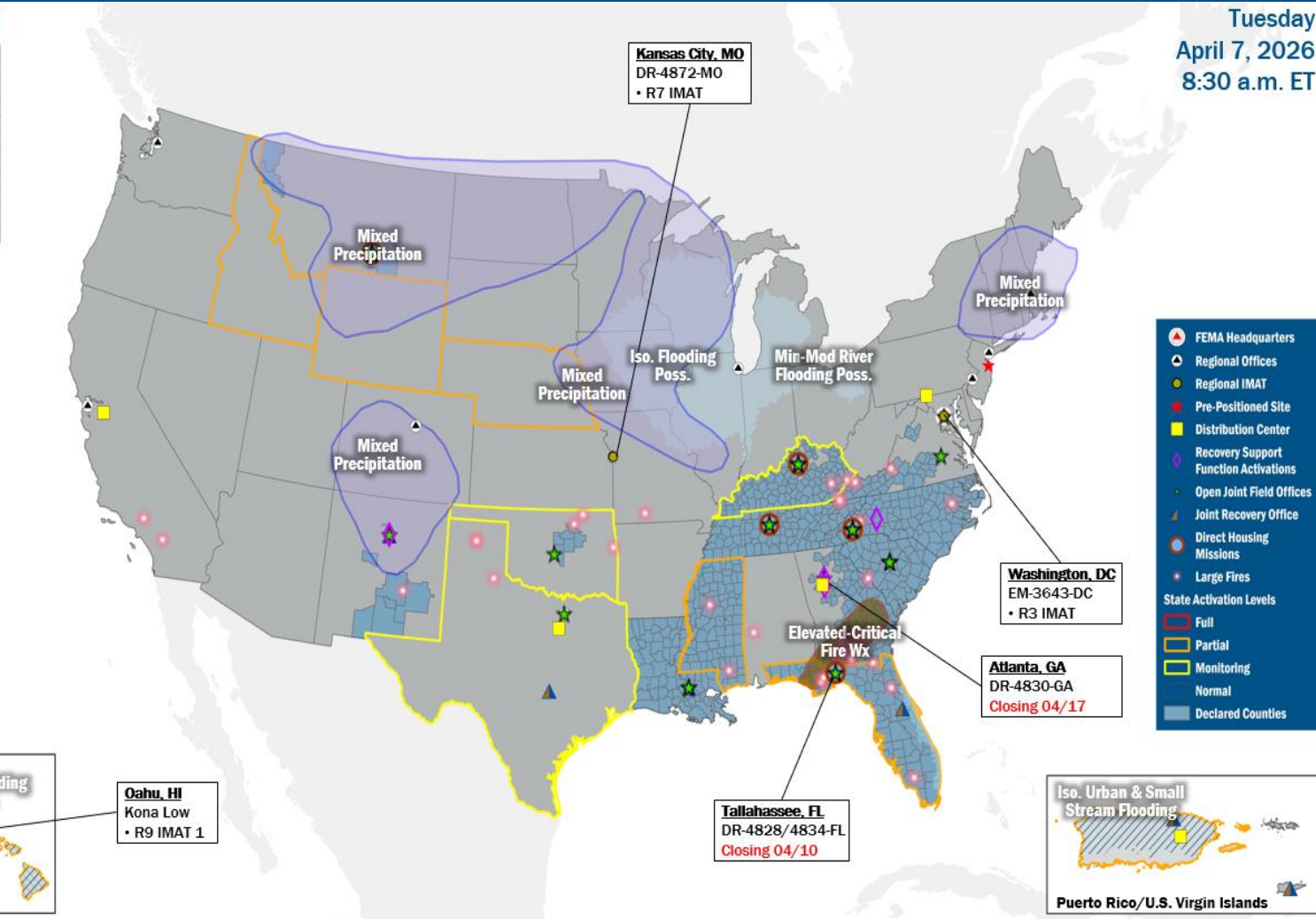
