<u>Current Situation</u>: Evacuation orders were lifted for East Cinder, Mills Plaza, and West Las Vegas in San Miguel County; Gallinas Corridor began repopulation on May 12. The fire is over Highway 518 and spreading rapidly; day and night crews are conducting defensive firing operations to reduce fuels ahead of the fire and around homes. Structure protection groups are still working in the Highway 518, 121, 434, and 442 corridors and canyon communities. Anticipated fire containment date is July 31. (Region VI RRCC Incident Report - Final as of 6:58 p.m. ET, May 13) Lifeline Impacts:

#### Safety and Security:

Initial damage assessments indicate 396 (+80) structures destroyed; 252 (+135) single-family homes, 114 (+4) manufactured homes, and 30 non-traditional homes are damaged


#### Food, Water, and Shelter:

- 6 (-6) shelters open with 660 (-189) occupants (ARC Morning Shelter Report as of 6:50 a.m. ET May 14)
- 2 shelters opened; Genoveva Chavez Community Center in Santa Fe County and Raton Community Center in Colfax County; currently have no occupants (NM Operational Summary May 12)

#### Health and Medical:

The Behavioral Health Institute in Las Vegas evacuated patients; re-entry began May 13



Current Situation: The fire continues to burn 3 miles SW of Los Alamos National Laboratory (LANL). 10,402 homes under "SET" voluntary evacuations, 1,619 homes under READY voluntary evacuations. LANL continues aggressive fire mitigation work between LANL property and the northeast section of the fire. There was significant fuel mitigation on the south and southwestern boundaries of LANL. If the fire breaches the Alamo Trail, the LANL and the Los Alamos County townsite will move into "GO" evacuation posture. LANL is currently in "SET" posture. The fire has burned 652 acres on Pueblo de Cochiti land and 2,972 acres of Pueblo of Jemez land and is now 17-20 miles from the Pueblo proper. The fire entered tribal land of Santo Domingo Pueblo on May 10. There are currently no impacts to critical infrastructure in the Pueblo of Jemez and Santo Domingo Pueblo; the fire is restricted to wildland at this time. Estimated containment date is May 21. (Region VI RRCC Incident Report - Final as of 6:58 p.m. ET, May 13)

<u>Lifeline Impacts</u> (Region VI RRCC Incident Report – *Final* as of 6:58 p.m. ET, May 13) **Safety and Security:** 

- Fire restrictions at Stage 3: DOE and county-maintained trails are closed; campfires and grilling are prohibited; no use of firearms; no use of unpaved recreational areas
   Hazardous Materials:
- The possibility of any nuclear or radiological incident due to the fire remains low

#### State / Local Response: (Region VI RRCC Incident Report - Final as of 6:58 p.m. ET, May 13)


- NM and LANL EOCs at Full Activation
- LANL at "SET" Evacuation posture; Laboratory will remain in maximum telework status until the fire is under control
- NM coordinating with CA on EMAC requests

#### FEMA / Federal Response:

#### **FEMA Headquarters:**

- NRCC at Level III (COVID-19); NWC continues to monitor
- Federal Staging Area (FSA)/Incident Support Base (ISB) are fully operational at the Albuquerque Expo Center with ISB/SMT teams, and IMAT equipment
- MERS: One MEOV and five MCOVs on site; 5 additional MCOVs requested; two
  arrived in Santa Fe, three to arrive May 14-15 for a total of 10 MCOVs; MCOVs
  being sent to support Ruidoso and Taos; coordinating to bring DSA and a MCOV
  to the Pojoague Pueblo
- Generators transferred to USACE; 10 assessments complete; 7 installations complete, and 3 paused for fire safety
- The additional 30 pack of generators arrived at FSA/ISB on May 12 to meet the request for 26 generators.
  - One generator was installed at Holman Water Department and one generator is being installed at Holman Elementary School
- Major Disaster Declaration FEMA-4652-DR-NM was approved on May 4





#### Region VI:

- RRCC at Level III (day shift) with ESF-2, 3, 4, 6, 7, 11, 12, 15; RRCC to field transition coordination in progress Estimated transition date: May 24
- Region VI IMAT-2 deployed to NM EOC
- DRC in Ruidoso expected to be fully operational on May 14; mobile DRC operations scheduled to begin May 14 in San Miguel, Santa Fe, and Taos counties (anticipated 3 total DRCs open by Saturday)
- 286 (+33) personnel deployed to FEMA-4652-DR-NM, including Disaster Survivor Assistance (DSA) personnel










### **Fire Weather Outlook**






### **Severe Weather Outlook**






### **Precipitation & Excessive Rainfall**


