




## Pacific Overview TROPICAL OUTLOOK






# Hurricane Helene SATELLITE LOOP



# Hurricane Helene FORECAST TRACK




## Hurricane Helene MOST LIKELY ARRIVAL OF TS WINDS




# Hurricane Helene PEAK STORM SURGE FORECAST

### Heighe Updated 6 AM EDT, Thursday September 26 OBSERVED PRECIPITATION last 24 hours (preliminary)











### Hurricane Helene – Southeast

Situation: Hurricane Helene is forecast to impact the Southeast. FEMA Region IV and FEMA Headquarters are actively preparing and pre-staging resources to support.


