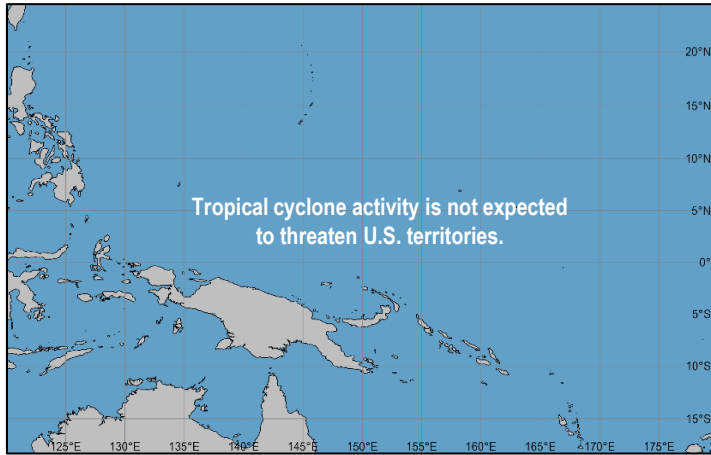

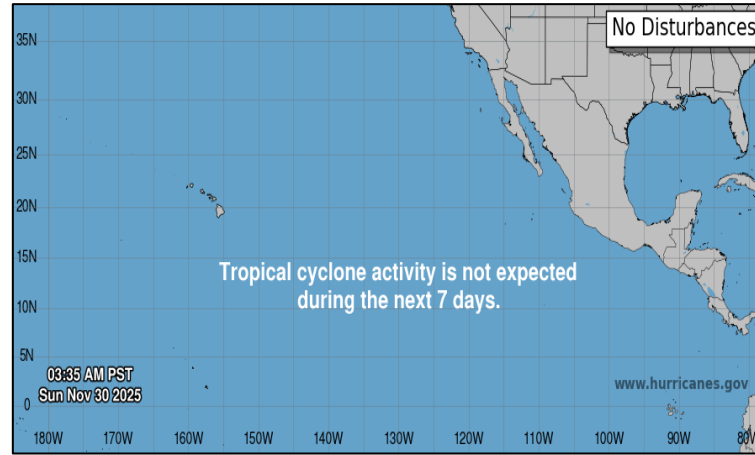

Western Pacific



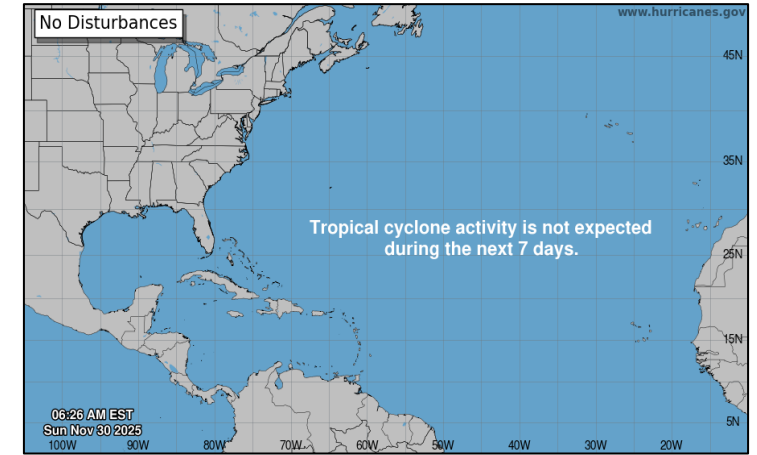

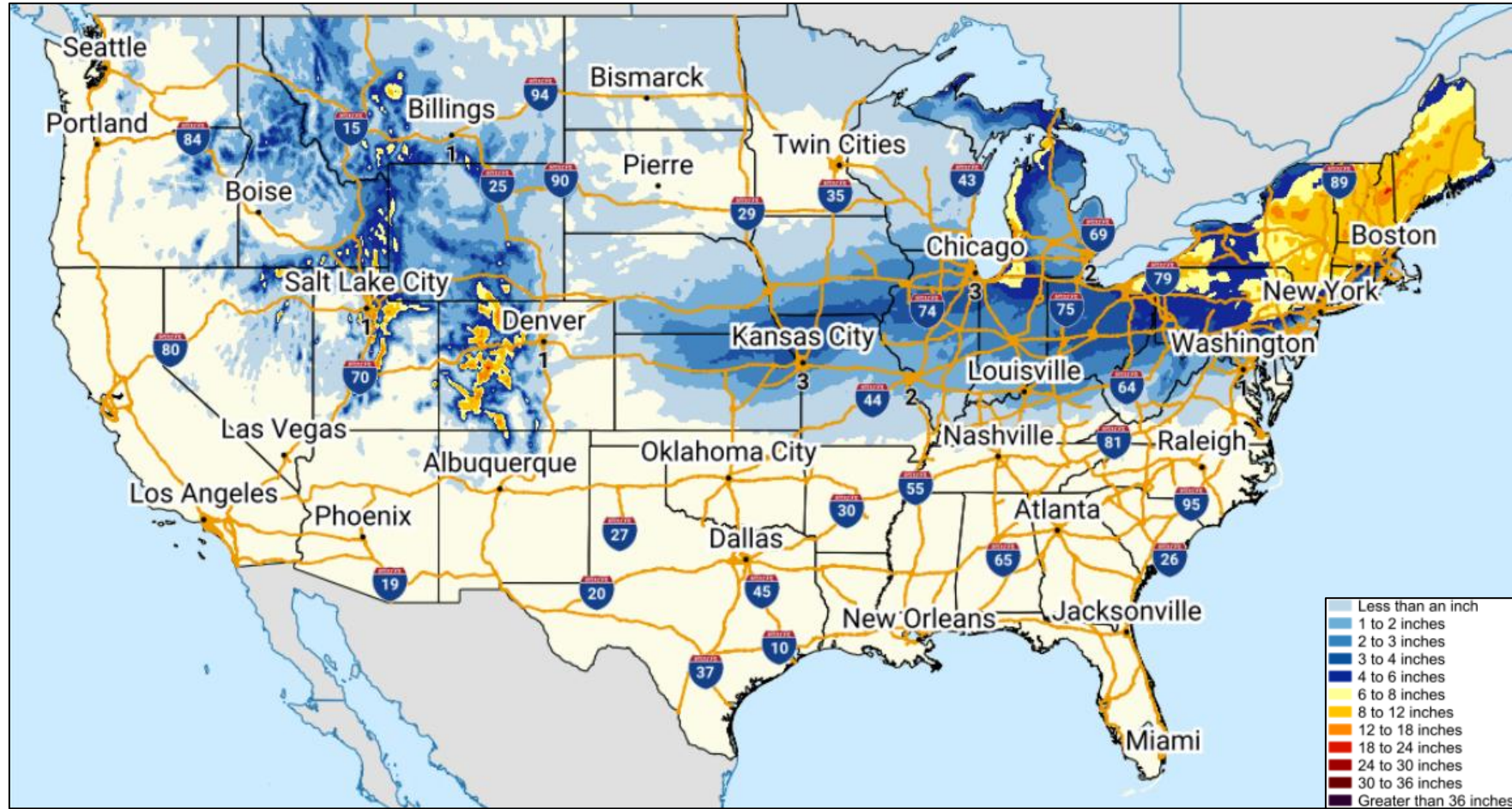
National Weather Forecast

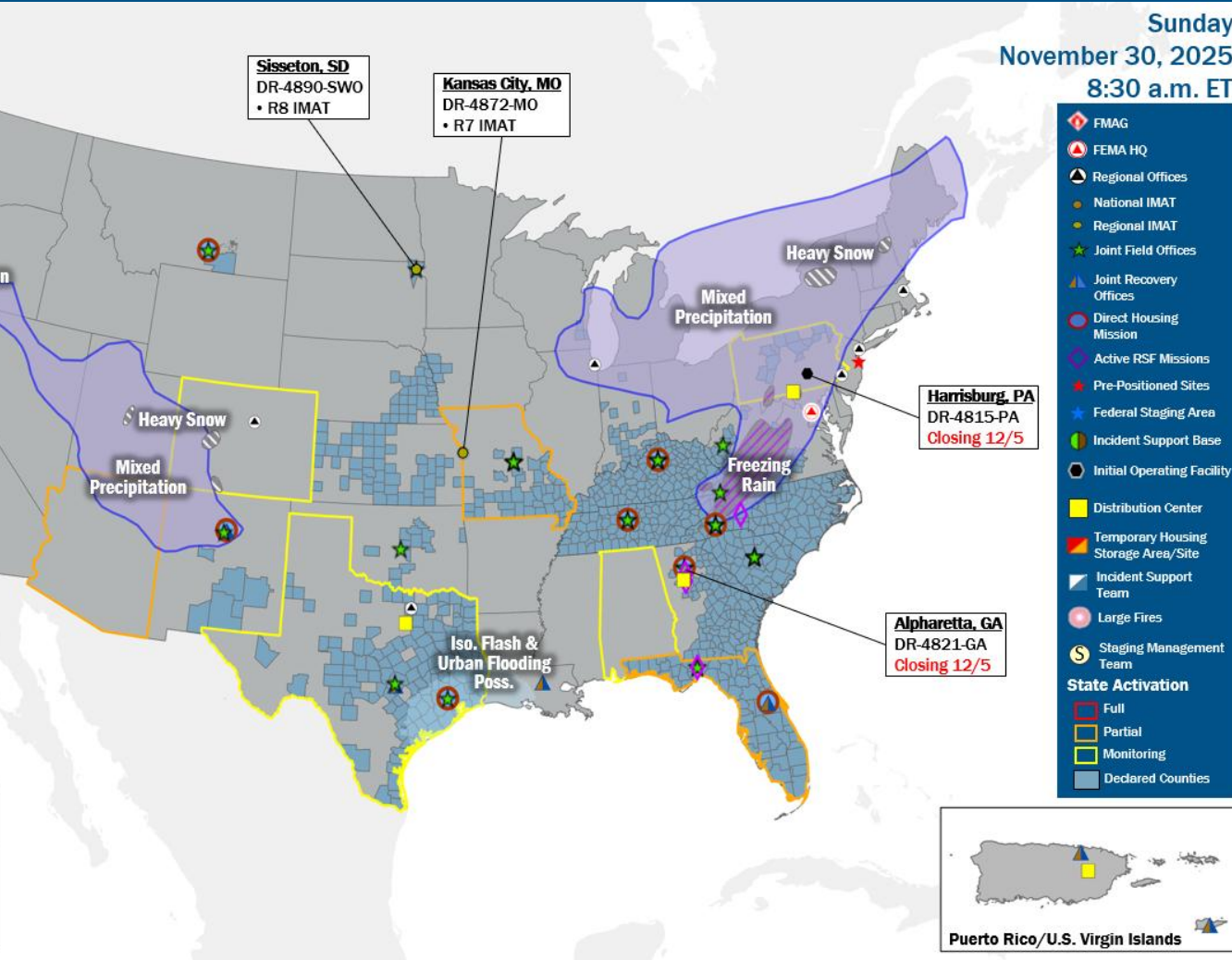
