Current Situation:

- Severe thunderstorms and heavy rainfall brought 10-18 inches of rain since Sunday across southeast Texas, including the Houston (Harris County) metro area, leading to significant flash flooding
- Threat for localized flash flooding and additional significant river flooding will continue through mid-week

Impacts

- Media is reporting over 1,200 high water rescues and 1,000 homes flooded (Harris County); No official numbers available - assessments ongoing
- Over 1,200 flights cancelled at airports across TX
 - Houston International operating with no current flight delays (Industry & Media reports)
- Multiple roads, I-45, & I-10 closed in Houston area (Texas DOT)
- Many schools/government offices closed
- Power restoration ongoing; 17k customers remain without power in the Region VI
 - o 15k in TX (peak 70k); 9k in Houston (peak 62k) (DOE Eagle-I as of 7:00 a.m. EDT)
- No damage to waste water facilities; no risk to flood control structures
- Unconfirmed reports of 5 fatalities; (4) Harris County, (1) Waller County
- 14 ARC shelters open w/ 437 occupants in the Houston area (ESF-6 report as of 7:00 a.m. EDT)

State/Local Response

- TX EOC at Monitoring (Level III)
- Governor declared a state of emergency for 9 counties on Apr 18th
- TX National Guard/TX Military Department Forces & SAR resources are activated






Precipitation Forecast, 1-3 Day











Significant River Flood Outlook


