
- Media is reporting over 1,200 high water rescues and 2,300 homes flooded (Harris County); No official numbers available - assessments ongoing
- Houston International Airport operating with minimal flight delays (Industry & Media reports)
- Road conditions improving, though some remain impassible, including I-10 in the Houston area (Texas DOT)
- Many schools/government offices remain closed Harris County
- Power restoration continues; 18k (peak 70k) customers remain without power statewide (DOE Eagle-I as of 7:00 a.m. EDT)
- City of Katy (Harris County) reporting some damage to one of two waste water facilities
- Unconfirmed reports of 8 (+3) fatalities
- 12 (-2) ARC shelters open w/ 263 (-174) occupants in the Houston area (ARC report 6:15 a.m. EDT)

- TX EOC at Monitoring (Level III)
- Governor declared a state of emergency for 9 counties on Apr 18
- TX National Guard/TX Military Department Forces & SAR resources activated





National Weather Forecast












Precipitation Forecast, 1-3 Day


WEST FORK SAN JACINTO RIVER NEAR HUMBLE


Convective Outlook Days 1-3






Hazard Outlook April 22-26






