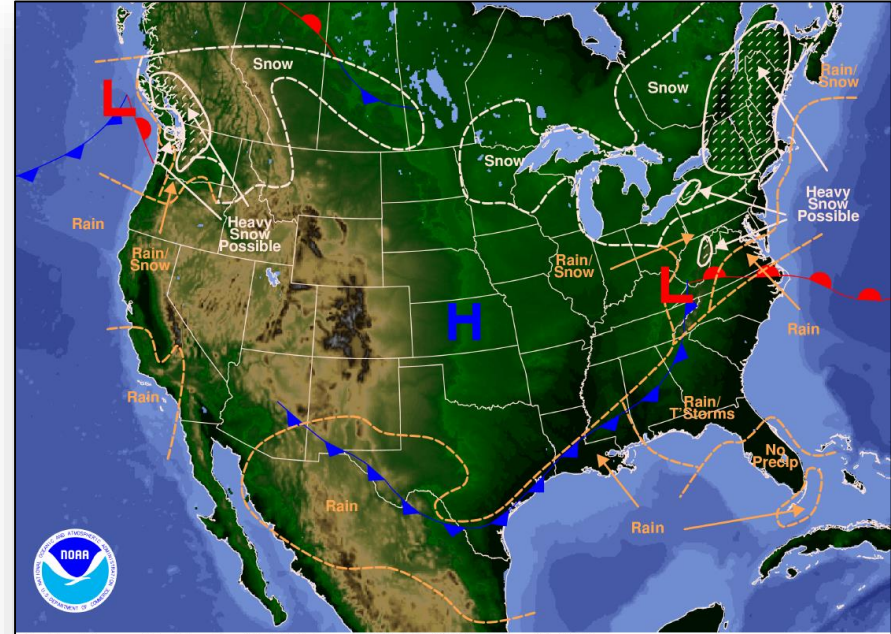

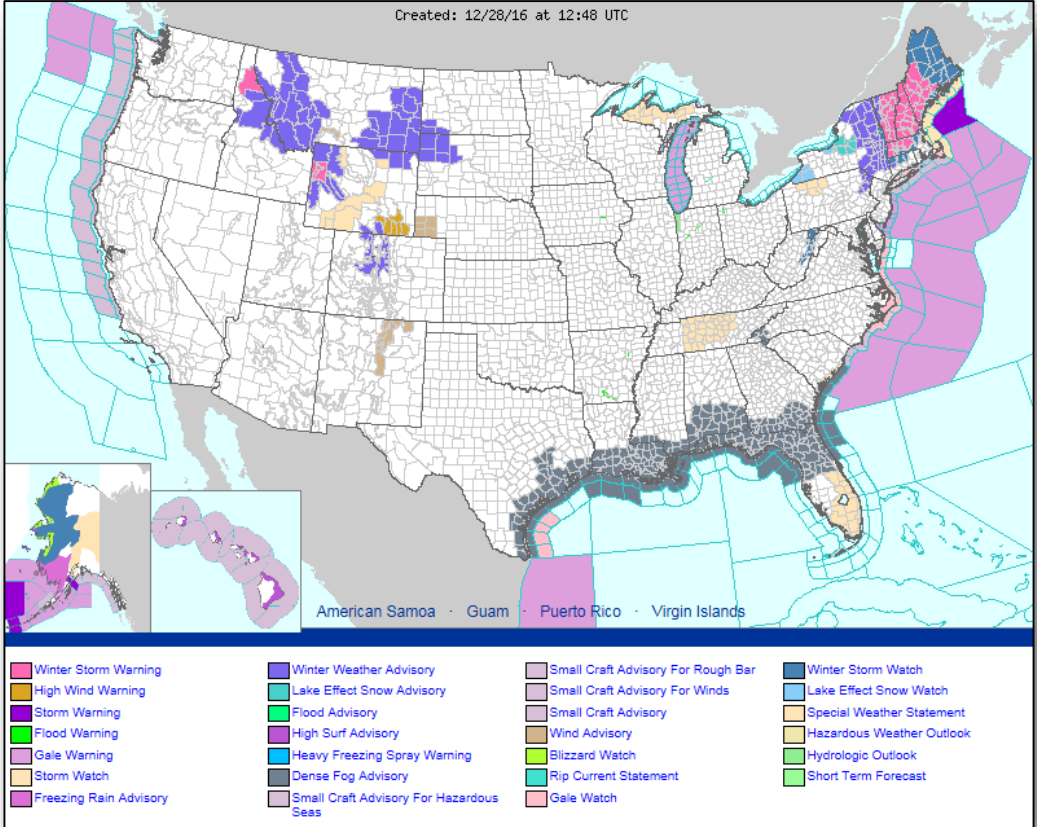

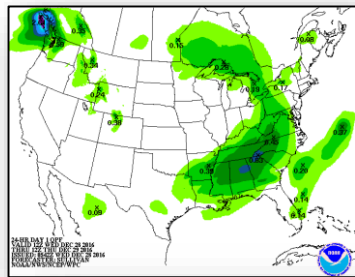

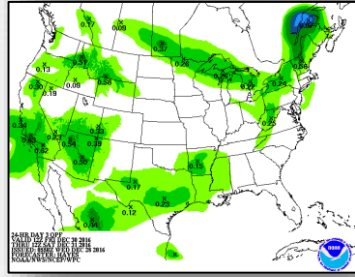
Precipitation Forecast – Days 1-3

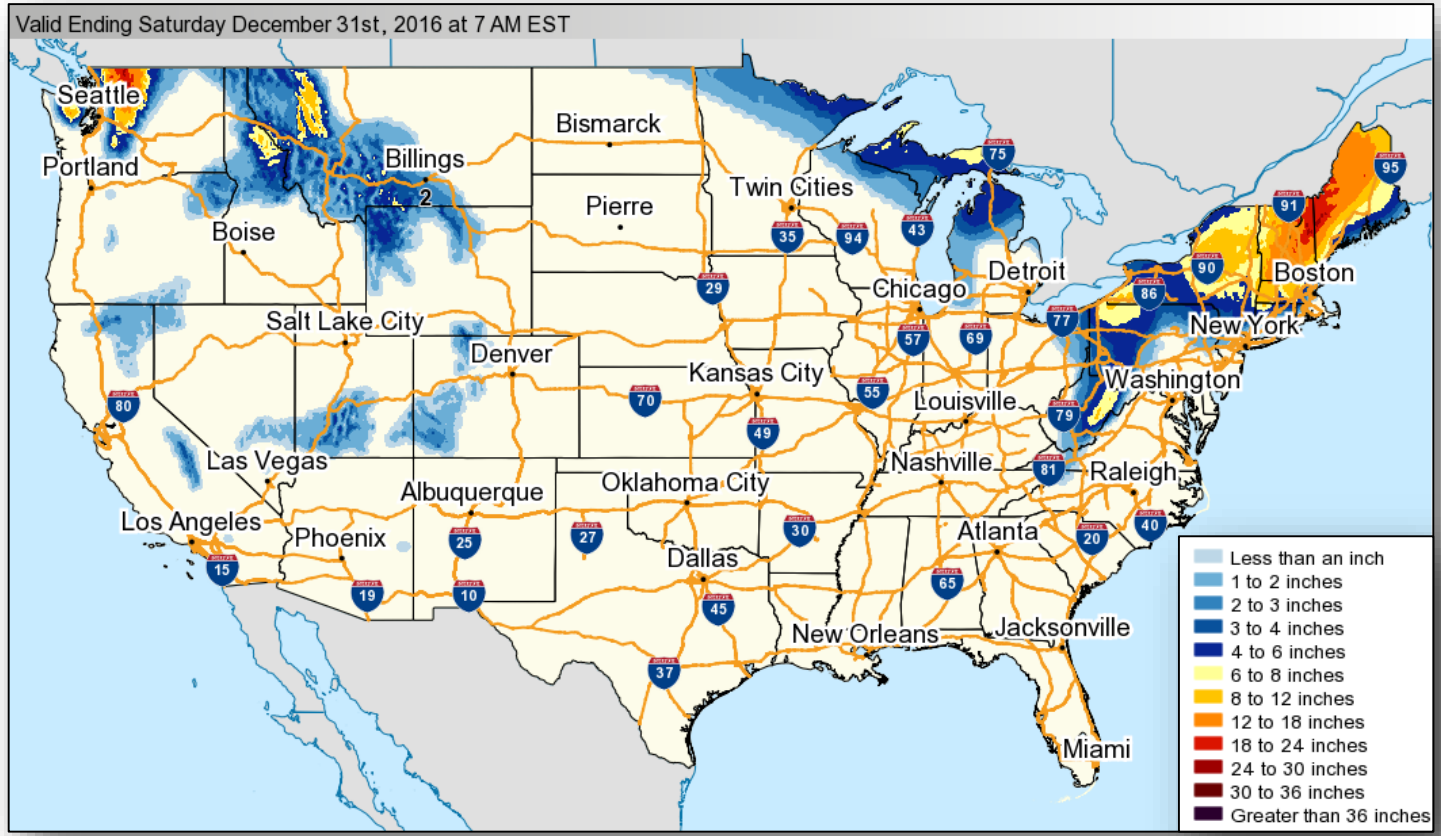

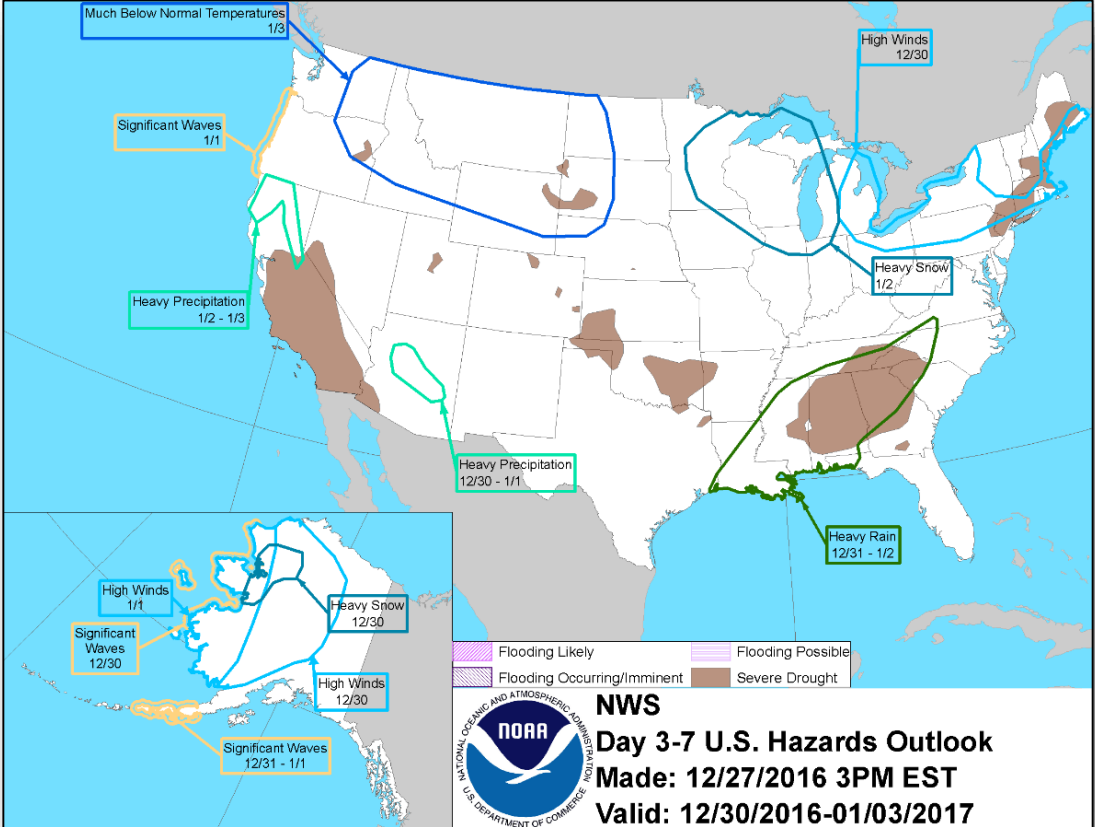

Hazards Outlook – Dec 30-Jan 03

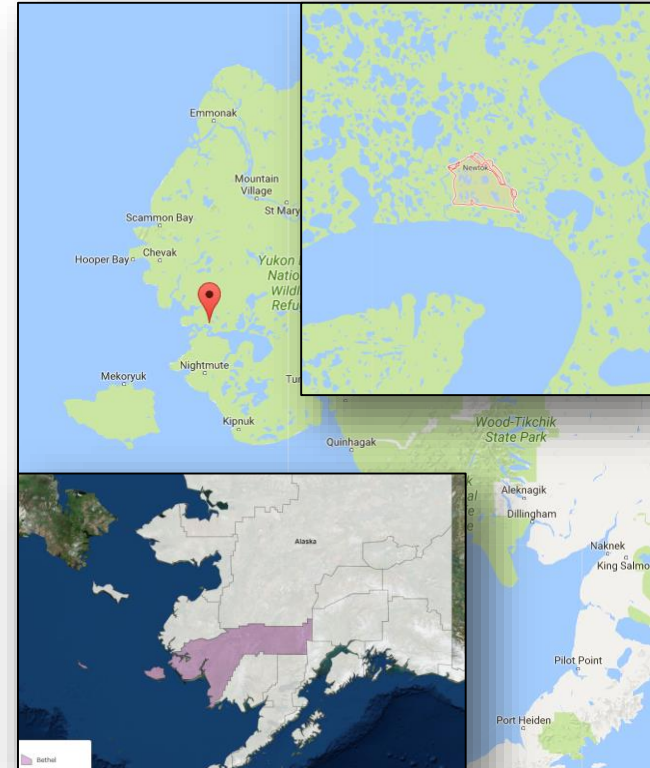


Declaration Request



Newtok Village, within Alaska

- On December 23, 2016 the Tribal President of the Newtok Village in Alaska requested a Major Disaster Declaration
- For periodic flooding, persistent erosion, and permafrost degradation beginning January 1, 2006 and continuing
- Requests:
 - Individual Assistance
 - Public Assistance (Categories C-G)
 - Hazard Mitigation to relocate the Yupik Tribe (pop. 350) from Newtok Village to Mertarvik, AK

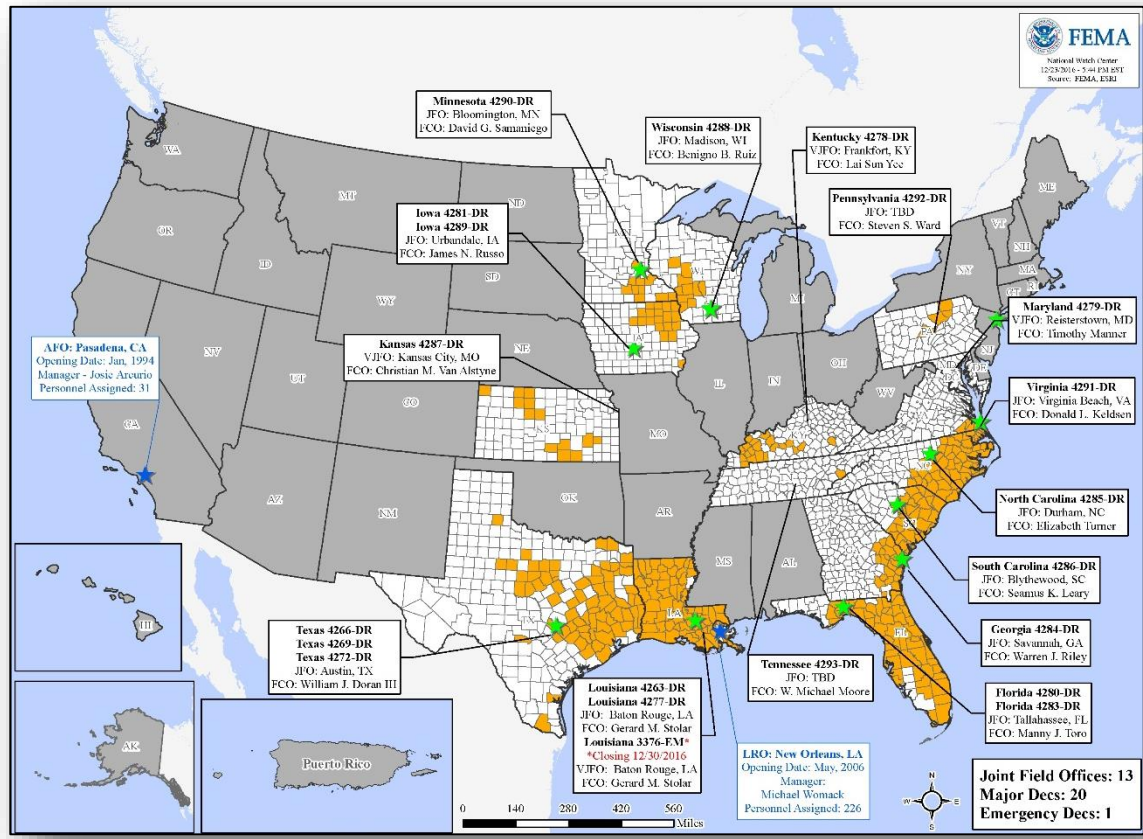
