2	We'll go on the record at 2:10 p.m. eastern.
3	Mr. <u>Durkin.</u> Let me ask this. I just got this voice message that said this meeting
4	is being recorded, which is fine with us. Does that mean we will get a copy?
5	Yes, and you'll get a copy of the transcript.
6	Mr. <u>Durkin.</u> Okay. But, that way, Julia won't have to kill herself taking
7	every dot every i or cross every t, right?
8	That's right.
9	Mr. <u>Durkin.</u> Okay.
10	Okay. Thanks, Tom.
11	Good afternoon. This is the deposition of Nicholas Fuentes, conducted by the
12	House Select Committee to Investigate the January 6th Attack on the United States
13	Capitol pursuant to House Resolution 503.
14	This will be a staff-led deposition, though members may choose to ask questions.
15	At this time, I'd ask the witness to please state your full name and spell your last
16	name for the record.
17	The Witness. Okay. Nicholas J. Fuentes. And my last name is F-u-e-n-t-e-s.
18	Thank you, Mr. Fuentes. Is the "J" an initial or is it J-a-y?
19	The Witness. That's my middle initial.
20	Great. And what's your middle name?
21	The <u>Witness.</u> Joseph.
22	Thank you.
23	Mr. Fuentes, my name is and I'm an investigative counsel with
24	the select committee.
25	With me from the select committee staff are senior counsel and

1	senior advisor; senior technical advisor; investigative	
2	counsel; professional staff member; nvestigative counsel;	
3	, investigative counsel; professional staff member. And I	
4	think that's everyone. I apologize if I left anyone off.	
5	In addition, there are the following members in attendance: Mr. Adam	
6	Kinzinger.	
7	Under House deposition rules, neither committee members nor staff may discuss	
8	the substance of the testimony today unless the committee approves release. You and	
9	your counsel will have the opportunity to review the transcript.	
10	Note that, under House rules, you may have your attorney present but counsel for	
11	other individuals or attorneys from other government agencies may not be and therefore	
12	are not present.	
13	I would like to note for the record that what has been previously marked as	
14	exhibit 1 is the select committee's January 19th, 2022, subpoena for Mr. Nicholas J.	
15	Fuentes. The House deposition rules are included in this exhibit.	
16	At this time, could counsel please state their name for the record?	
17	Mr. <u>Durkin.</u> Tom Durkin for the witness.	
18	Thank you, Mr. Durkin. I believe you have two colleagues	
19	attending with you?	
20	Mr. <u>Durkin.</u> Yes.	
21	Can you please introduce them as well?	
22	Mr. <u>Durkin.</u> My paralegal, Julia Dratel, is on the I don't know if you can see her	
23	or not. I can't. And my law clerk, Nicholas Athenson, is also on.	
24	Great. Thanks, Mr. Durkin.	
25	There is an official reporter transcribing the record of this deposition. Please	

1	wait until each question is completed before you begin your response, and we'll try to
2	wait until your response is complete before we ask our next question.
3	The stenographer can't record nonverbal responses such as shaking your head, so
4	it's important that you answer each question with an audible, verbal response. Do you
5	understand?
6	The <u>Witness.</u> Yes.
7	Thank you.
8	We ask that you provide complete answers based on the best of your recollection
9	If the question is not clear, please ask for clarification, and if you don't know the answer,
LO	please simply say so.
l1	You may only refuse to answer a question to preserve a privilege that's recognized
L2	by the select committee. If you refuse to answer a question based off of a privilege,
L3	staff may either proceed with the deposition or seek a ruling from the chairman on the
L4	objection. If the chairman overrules such an objection, you're required to answer the
L5	question.
L6	I also want to remind you that it's unlawful to deliberately provide false
L7	information to Congress. Providing false information could result in criminal penalties
L8	for perjury and/or providing false statements, including under 18 U.S.C. section 1001,
19	which makes it illegal to provide a false statement in a congressional investigation.
20	That being said, to be clear, this is a congressional investigation, not a criminal
21	investigation. This proceeding is separate and distinct from any current criminal
22	proceeding by the United States Department of Justice.
23	Do you have any questions about what I just said, Mr. Fuentes?
24	The <u>Witness.</u> No.
25	So, logistically, please let us know if you need any breaks. I just

1	simply ask that, if you request a break, you answer the question that's pending before we			
2	break.			
3	If you don't understand a question, please simply ask me to restate it or clarify it.			
4	We aren't trying to trick you today, so if there's a question you don't understand, I'm			
5	more than happy to clarify it.			
6	Finally, I'll note that I'll be leading our conversation today but occasionally other			
7	staffers or even members may join in, and as members join, I will announce that they've			
8	joined the meeting.			
9	So, because this deposition is under oath, would you please raise your right hand			
10	to be sworn by the reporter?			
11	The Reporter. Do you solemnly declare and affirm under the penalty of perjury			
12	that the testimony you are about to give will be the truth, the whole truth, and nothing			
13	but the truth?			
14	The <u>Witness.</u> Yes.			
15	Thanks, Mr. Fuentes.			
16	, could we please pull up exhibit 1?			
17	This is the subpoena that was issued by the select committee to Mr. Fuentes on			
18	January 19th, 2022. I'll note that the exhibit contains the subpoena itself, a cover letter			
19	from the chairman, a document schedule with production instructions, and a copy of the			
20	House rules and regulations regarding conducting depositions.

23	Q Mr. Fuentes, could you please confirm that this subpoena is addressed to			
24	you?			
25	A Yes.			

1 Q And you understand that you're appearing here today pursuant to this 2 subpoena, correct? Α Yes. 3 4 Q Thank you. 5 We can take the exhibit down. So, Mr. Fuentes, I'd like to start with some really basic information to learn a little 6 7 bit more about you. Can you tell me a little bit about yourself and where you grew up? 8 Sure. I grew up in La Grange Park, Illinois. I've lived there my whole life. 9 And now I'm a livestreamer for a living. 10 Q Great. And are you still in La Grange, Illinois? Α No. I am in Berwyn, Illinois, now. 11 Q Great. 12 Can you tell me about your educational history? 13 14 Α Yes. I went to Boston University for two semesters in 2016 and '17, and then I got an associate's degree from College of DuPage. I believe I completed that in 15 16 2019. Q Great. Thank you. 17 Have you ever served in the military? 18 19 Α No. 20 Q Have you ever been employed by an office of government? Α 21 No. Q Have you ever held elected or appointed office in government? 22 23 Α No. Have you ever received grant money or a contract from an office of 24 Q

government?

1	A No.
2	Mr. <u>Durkin.</u> , could I interject and just ask a point of procedure?
3	As you know from our correspondence in response to your subpoena, under my
4	advice he's going to assert the Fifth Amendment privilege against self-incrimination.
5	If I were there in person he has a sheet that he will read from I would simply
6	point to that and, you know, nod my head or something. I don't want to interfere, but
7	I'm going to advise him to answer that question with what I advised him to say. And I
8	don't know you want to handle that.
9	I think, for the sake of time, you know, if we have an I would recommend we
10	have an understanding that if I think there's a question he should answer, I would say so
11	but, otherwise, from this point on, I believe, based on where your questions sound like
12	they're going to go, I'm going to recommend he take the Fifth Amendment.
13	Okay. Well, you know, we can my plan is to proceed with the
14	questions, and if you or Mr. Fuentes have objections, we can take a pause and you can
15	either advise him to raise an objection at that time or Mr. Fuentes can raise the objectio
16	himself if he'd like to.
17	And then I would ask that you explain I don't know what the script says, but we
18	do request an explanation for why the privilege is being raised.
19	Does that sound okay, Mr. Durkin?
20	Mr. <u>Durkin.</u> Well, but no, that doesn't. That is disturbing to me. I already
21	told you why he's why I'm recommending that he take the Fifth Amendment. I've
22	provided you that basis in the correspondence. I don't I mean, is my correspondence
23	part of the exhibits that you have?
24	It is, yes.
25	Mr. <u>Durkin.</u> I don't think it's necessary for me to restate it if it is in the record.

1	But, as you know, he has been told he is a subject and possibly a target of a Federal			
2	criminal investigation being conducted by the United States Attorney's Office for the			
3	District of Columbia. They confirmed that same status, as you know, quite recently,			
4	so and, as I've told you, I think that's unfortunate, because, otherwise, he would be			
5	willing to testify.			
6	But the questions I just think it's an impossible situation that he's in, in light of			
7	the pending grand jury investigation. So I don't want any of the committee to think			
8	we're trying to be disrespectful or anything else. You know, we have respect for the			
9	committee. But that's my advice.			
10	So, I mean, I don't consider taking a privilege to be an objection, you know. He			
11	has			
12	Absolutely. And I think you very helpfully just laid out the basis			
13	for situations in which Mr. Fuentes might raise a privilege in response to a question. So			
14	that was helpful, and thank you for doing that.			
15	Mr. <u>Durkin.</u> Okay.			
16	And, just to clarify, I had asked if Mr. Fuentes had ever received			
17	grant money or a contract from an office of government.  Are you raising a privilege in			
18	response to that question?			
19	Mr. <u>Durkin.</u> No, I'll let him answer that. Next but go ahead. Next			
20	question.			
21	Great.			
22	And I believe the answer was no, correct, Mr. Fuentes?			
23	Mr. <u>Durkin.</u> I think he already he already answered it no, I believe, right?			
24	I just want to confirm.			
25	The Witness. Correct.			

1	Okay. Great.
2	BY
3	Q Mr. Fuentes, are you currently employed?
4	A Uh
5	Mr. <u>Durkin.</u> Nick.
6	The Witness. Upon the advice of counsel and in reliance upon the Fifth

8	that question on the grounds that it might tend to incriminate me.

3	A Upon the advice of counsel and in reliance upon the Fifth Amendment to the	
4	Constitution of the United States, I most respectfully refuse to answer that question on	
5	the grounds that it might tend to incriminate me.	
6	Q Mr. Fuentes, when was the first conference held?	
7	A Upon the advice of counsel and in reliance upon the Fifth Amendment to the	
8	Constitution of the United States, I most respectfully refuse to answer that question on

10	Q Mr. Fuentes, I have a series of questions related to your involvement with	
11	the America First Political Action Conference. Is it your intention to assert the Fifth

15	Q Mr. Fuentes, do you hold positions of leadership in any other organizations	
16	or corporate entities?	
17	A Upon the advice of counsel and in reliance upon the Fifth Amendment to the	
18	Constitution of the United States, I most respectfully refuse to answer that question on	
19	the grounds that it might tend to incriminate me.	
20	Q Mr. Fuentes, is there any kind of membership structure or dues-paying	
21	structure for people who say that they're affiliated with the America First movement?	
22	A Upon the advice of counsel and in reliance upon the Fifth Amendment to th	
23	Constitution of the United States, I most respectfully refuse to answer that question on	
24	the grounds that it might tend to incriminate me.	
25	Q Thank you, Mr. Fuentes.	

1		Mr. Durkin, if I might suggest something for the sake of
2	expediency	. I don't think it's necessary for Mr. Fuentes to state his full statement each
3	time. If h	e wants to say "Fifth Amendment," that should be sufficient.
4	Mr.	<u>Durkin.</u> That's fine.
5		We'll with the understanding that that is shorthand for his full
6	statement.	
7	Mr.	<u>Durkin.</u> That's fine.

9	Q	Mr. Fuentes, do you maintain a membership list?
10	Α	Fifth Amendment.
11	Q	Mr. Fuentes, I have a series of questions related to the America First
12	movement	and the Groypers and any sorts of membership structures or people who
13	might be af	filiated with those movements. Is it your intention to assert the Fifth
14	Amendmer	nt in response to all questions the committee has related to those subjects?
15	Α	Yes.
16	Q	Mr. Fuentes, did you hold any position in the Stop the Steal organization?
17	Α	Fifth Amendment.
18	Q	Mr. Fuentes, can you describe your affiliation with the Stop the Steal
19	organizatio	n or the individuals leading it?
20	А	Fifth Amendment.
21	Q	Okay.
22	Mr.	Fuentes, what social media platforms do you currently use?
23	А	Fifth Amendment.
24	Q	Mr. Fuentes, what platforms have you previously used?
25	А	Fifth Amendment.

1	Q	Mr. Fuentes, I have a series of questions related to your use of social media,
2	setting the	issue of livestreaming aside. Do you have is it your intention to assert the
3	Fifth Amendment in response to all questions the committee has related to your social	
4	media usag	e?
5	А	Yes.
6	Q	Thank you.
7	Mr.	Fuentes, I understand from a letter from your attorney that you claim to be on
8	the no-fly li	st. What are the issues that you've encountered while traveling?
9	А	Fifth Amendment.
10	Q	Okay. Mr. Fuentes, when did those issues start?
11	А	Fifth Amendment.
12	Q	Mr. Fuentes, I have a series of questions related to your assertion that you're
13	on the no-fly list. Is it your intention to assert the Fifth Amendment in response to all	
14	questions the committee has on that subject?	
15	Α	Yes.
16	Q	Thank you.
17	Mr.	Fuentes, I'd like to move into your use of livestreaming. Which livestreaming
18	platforms have you used?	
19	А	Fifth Amendment.
20	Q	Mr. Fuentes, are you currently livestreaming?

9	l'd li	ke to discuss a way for the committee to get the videos that are available on
10	that websit	e that are behind the paywall. Is that something that Mr. Fuentes would be
11	able to tran	smit to the committee?
12	Mr.	<u>Durkin.</u> I'd like to discuss it with him. I'm not aware of that, but, you know
13	it that ma	ay be.
14		Okay. Well
15	Mr.	<u>Durkin.</u> I mean, I'm not quite sure I understand. Are you saying that you
16	want us to	save you the cost of it? I mean, is it not something you can get to with
17	a l'm not	sure what the question is.
18		I'm asking whether you can produce the videos that Mr. Fuentes
19	has made a	vailable to people who pay on his website.
20	Mr.	<u>Durkin.</u> You don't want to pay. Is that it? I'm just joking. That's a joke.
21	Let i	me talk to him. We can I don't see a problem with that, but I'd like to
22	discuss it w	ith him.
23		All right. Thank you. And, you know, to the extent that those
24	actual video	os fall into one of the items within the production schedule, he's required to
25	produce the	em pursuant to the subpoena. But we can discuss that after the deposition.

1	Mr. <u>Durkin.</u> Okay.
2	BY
3	Q Mr. Fuentes, do you make money from livestreaming?
4	A Fifth Amendment.
5	Q Mr. Fuentes, I'd like to return to one of my questions. Are you currently
6	livestreaming this deposition?
7	A Tom, can I answer this?
8	Mr. <u>Durkin.</u> Not without talking to me.
9	Can I talk to him,
10	Sure. If you want to mute and stop your video, we can go off
11	the record briefly, and you can call each other or communicate however you'd like.
12	All right. We'll go off the record at 2:31 p.m.
13	[Discussion off the record.]
14	Let's go on the record at 2:32 p.m.
15	Mr. Fuentes, I had asked if you're currently livestreaming this deposition.
16	Mr. <u>Durkin.</u> And I'll represent to you that he is not.
17	Okay. Thank you.
18	Mr. Durkin, I'd like to understand the breadth of Mr. Fuentes' assertion of the
19	Fifth Amendment. For example, I asked if he currently livestreams as a general matter.
20	I'm not sure I understand why that would tend to incriminate him.
21	Mr. <u>Durkin.</u> I think it could be a piece of evidence that could be used in the
22	building block or the chain theory, that it's an admission that he does certain things,
23	which would be a step towards some other piece of proof.
24	Mr. Durkin, I'm not sure, if Mr. Fuentes' livestreams are available
25	online, why it would tend to incriminate him to answer the question of which

1	livestreaming platforms does he use or has he used.
2	Mr. <u>Durkin.</u> Well, we've had this conversation,
3	One, frequently, government attorneys take the position that answering any
4	question then constitutes a waiver, any substantive question. And I think those are
5	substantive questions.
6	I don't I'll simply stand on my advice to him. I think it's a I don't want there
7	to be a waiver, and I don't want there to be I don't want there to be any suggestion of a
8	waiver.
9	Is there a time period over which you're asserting Fifth
10	Amendment privileges?
11	Mr. <u>Durkin.</u> I'm not sure I understand that question.
12	If I asked about Mr. Fuentes' activities in early 2020 or prior to
13	that, is it your assertion that even answering those questions would tend to incriminate
14	him?
15	Mr. <u>Durkin.</u> I think it's certainly feasible it could be. It's my understanding from
16	at least some charges that have already been brought that the government is
17	investigating and bringing charges against people for conspiracy that begins, you know,
18	well before some of those dates. So, I mean, yes, that would still be my advice.
19	Okay. We'll move on with the questions.

21	Q Mr. Fuentes, is livestreaming your primary source of income?

L8	Mr.	Durkin. What was the question again?
L9		Has he ever been removed from a bank or has his account ever
20	been remov	ved from a bank?
21	Mr.	Durkin. Well, I think I told you in the letter that he received word that two
22	credit cards	at the Bank of America were two credit card accounts were removed or
23	canceled or	whatever you want to say, whatever I said in the letter, and that he
24	understand	s that they are also going to cancel the account. I don't think I said that the
25	account had	d been canceled.

1	Okay. So his account has not yet been canceled, but his
2	understanding is that it will be?
3	Mr. <u>Durkin.</u> That's what it was at the time I wrote the letter. I haven't asked
4	him about it since, but is that a correct understanding, Nick?
5	The Witness. So am I permitted to explain here on this one?
6	Mr. <u>Durkin.</u> Well I mean, I'm certainly willing to provide that information to
7	the committee. I just don't know that I want him to answer the question,
8	Okay. We can follow up, and maybe you can provide that
9	information in writing?
LO	Mr. <u>Durkin.</u> Yes.

22	Q You sell merchandise that has the America First branding or the AF logo of
23	your website. Are you the one who runs those sales?
24	A Fifth Amendment.
>5	O Do you make a profit from those sales?

1	Α	Fifth Amendment.
2	Q	Do you maintain any other online stores?
3	Α	Fifth Amendment.
4	Q	Mr. Fuentes, what payment processors do you currently use?
5	Α	Fifth Amendment.
6	Q	Have you been removed from any payment processors?
7	Α	Fifth Amendment.
8	Q	Mr. Fuentes, did you fundraise for the America First Foundation or any other
9	organization	that you have a leadership role in in the period prior to the 2020 election?
10	Α	Fifth Amendment.
11	Q	Did you fundraise for the Trump campaign?
12	Α	Fifth Amendment.
13	Q	Did you fundraise for any grassroots efforts to elect Trump?
14	Α	Fifth Amendment.
15	Q	Did you fundraise for any other candidates for the 2020 election?

17	Q	Mr. Fuentes, I have the same questions for the period between the election
18	and January	6th, did you fundraise for any of those organizations or campaigns or
19	candidates.	Is it your intention to assert the Fifth Amendment in response to those
20	questions?	
21	Α	Yes.
22	Q	Mr. Fuentes, have you ever received donations in kind?
23	Α	Fifth Amendment.
24	Q	Have you ever used the events of January 6th in any of your fundraising
25	pitches?	

1	A Fifth Amendment.
2	Q Do you currently have a person in charge of maintaining the America First
3	Foundation finances or the finances of any other organization you have a leadership role
4	in?
5	A Fifth Amendment.
6	Q Mr. Fuentes, I'd just like to return to the question I raised earlier. Are you
7	recording this deposition in any way?
8	The Witness. Tom, can I answer this one?
9	Mr. <u>Durkin.</u> Not without speaking to me.
10	The Witness. All right.
11	Then Fifth Amendment.
12	Mr. <u>Durkin.</u> Well, I don't know that we need to take the Fifth Amendment. Can
13	we just speak briefly, we will a second ?
14	Yes. We'll go off the record at 2:40 p.m.
15	[Discussion off the record.]

8	Mr. <u>Durkin.</u> Well, I'm not sure I understand the basis of the question either. I
9	mean, if you know something I don't know as far as I know, he hasn't been, but I'm not
10	following the
11	Well, thank you, Mr. Durkin. You just provided an answer to the
12	question. I didn't understand the assertion of the Fifth Amendment in response to that
13	question. But you confirmed that he has not been interviewed by Federal law
14	enforcement in connection with January 6th. Is that correct?
15	Mr. <u>Durkin.</u> As far as I know, I believe can we talk? Can I speak to him?
16	Yes. My well, and I think
17	Mr. <u>Durkin.</u> I think I go ahead. I'm sorry.
18	Can I preview my next question?
19	Mr. <u>Durkin.</u> Sure.
20	And you may want to discuss that as well.
21	Mr. Fuentes, have you turned over any records or devices to Federal law
22	enforcement in connection with January 6th or since January 6th, 2021?

6	anything about his beliefs whatsoever, or his followers.
7	And I just think that's kind of a bit of grandstanding, if you don't mind me saying
8	that. I don't mean that disrespectfully, but I just don't think that's an appropriate

10	I certainly understand your position on that, Mr. Durkin. I will
11	note the irony of an accusation of grandstanding in a deposition of Mr. Fuentes.

8	Mr. Fuentes has on his website that are behind a paywall and getting those produced to
9	the committee as soon as possible.
10	And, lastly, I was hoping, Mr. Fuentes or Mr. Durkin, if you could just walk us
11	through the process that, Mr. Fuentes, you've gone through to assess whether you have
12	any responsive documents to the committee's document request?
13	Mr. <u>Durkin.</u> I think that you and I can work that out. We so far you know, are
14	we still on the record?
15	Yes.
16	Mr. <u>Durkin.</u> And what's the question? What have we done?
17	Yes. I just wanted an overview of the process by which you've
18	determined whether there are no responsive records in some cases. I know you've
19	raised privileges in response to some of the items, and I'm not
20	Mr. <u>Durkin.</u> Yeah. No, I spoke
21	I'm not challenging that.
22	Mr. <u>Durkin.</u> I spoke to him yesterday. I have an issue I want to discuss with
23	you offline or off the record on these chats. It's more of a burden problem than
24	anything else that maybe we can accommodate. It's just becoming a bigger project than
25	he thought, and I'm not quite sure how to handle it, because I'm not, frankly,

1	sophisticated enough to what I'm getting at is, there may be a way that I could find an
2	expert or something that might be able to gather that information easier than he can.
3	It's becoming more burdensome than he expected which I'm happy to report I
4	predicted he would have a problem with when I heard what the task was going to be to
5	do it, like, individual screenshots.
6	With respect to the financial records, as I discussed with you over his traveling
7	expenses and so forth, I think I have a way of breaking that down to you that we can get i
8	to you in a manageable format.
9	Great. And I'm happy to continue the discussion offline.
LO	You've been very professional throughout all this, and I just want to acknowledge that
l1	you've been your efforts to meet the committee's deadlines have been appreciated.
L2	I also just want to state for the record that the committee has not received any
L3	production thus far from Mr. Fuentes. And I'm not talking about the set of items for
L4	which you've raised privilege. Setting those aside.
L5	So, given the committee's pace of investigation, I just want to emphasize how
L6	important it is that we to the extent that there are responsive documents and to the
L7	extent that you're not raising privilege on those documents, that the committee get those
L8	as soon as possible. But we can have that conversation.
L9	Mr. <u>Durkin.</u> I agree.
20	Great.
21	Mr. <u>Durkin.</u> The other problem, I might add, is that, unfortunately, Mr. Rascia's
22	mother passed away last night, and so he's been very distracted, as you can imagine, for
23	the last week or two. So it's been and that's why he was not here today. He was not
24	trying to be disrespectful, but she just passed away last night.


Completely understood. I'm very sorry to hear that, and please
