2	. Good afternoon. This is a transcribed interview of Daniel
3	Herendeen conducted by the House Select Committee to Investigate the January 6th
4	Attack on the United States Capitol pursuant to House Resolution 503.
5	At this time, I'd ask the witness to please state your full name and spell you last
6	name for the record.
7	Mr. <u>Herendeen.</u> It's Daniel J. Herendeen. Herendeen is H-e-r-e-n-d-e-e-n.
8	Thank you very much.
9	So this is a staff-led interview. I don't see any members on the call, but they may
LO	hop in and choose to ask questions, if they do so.
1	Speaking is , investigative counsel. And with me in the room is
L2	, also investigative counsel.
L3	So, at this time, could counsel please state your name for the record?
L <b>4</b>	Ms. Fitzharris. Yes. Colleen, Fitzharris. I'm a Federal community defender in
15	the Eastern District of Michigan.
L6	. Thank you very much.
L <b>7</b>	There is an official reporter transcribing the record of this interview. Please wait
L8	until each question is completed before you begin your response, and we will try to wait
L9	until your response is complete before we ask our next question.
20	The stenographer cannot record nonverbal responses such as shaking your head,
21	so it is important that you answer each question with an audible verbal response. And i
22	I ever see, you know, you nodding yes or shaking no, I'll just mention it for the record and
23	we can confirm and move on.
24	We ask that you provide complete answers based on your best recollection. If

the question is not clear, which very much is possible, please ask for clarification. 

If you

do not know the answer, please simply say so.

And then I'm going to go through a couple of, like, important points. So, first, it's important that you understand that this interview is voluntary. If at any time you would like to stop speaking with us, that is your choice. Similarly, if at any point you need to discuss something with your attorney in private, please let us know and we'll take a break so you and Ms. Fitzharris can have that conversation.

Second, this interview is not under oath. But because this is a formal congressional investigation, you are obligated under Federal law to tell the truth, the same as if you were speaking with the FBI or the Department of Justice. It is unlawful to deliberately provide false information to Congress. For this interview, providing false information could result in criminal penalties for false statements. Do you understand?

Mr. <u>Herendeen.</u> Yes.

<u>.</u> Thank you.

Third, you are not obligated to keep the fact of this interview and what we discuss confidential. You are free to tell whomever you wish that you met with us, including the prosecutor or the judge on your case, or you can tell no one at all. That is your decision.

Fourth, the select committee is separate and independent from the Department of Justice. We have no involvement with the prosecutions. And DOJ is not a part of the select committee in its investigation. The select committee also is not a party to your criminal case and is not agreeing to submit anything on your behalf to the judge. Nor can we make any representation whether, if you tell the judge you met with us, that the judge will be more favorable to you during sentencing.

Fifth, we have agreed with Ms. Fitzharris not to share the substance of what you say with the Department of Justice prior to your sentencing. But there are two possible exceptions. If you told us about evidence of a crime that we thought law enforcement

1	was unawai	re of or if we had reason to believe you lied during this interview, then we
2	would be ol	oligated to tell DOJ or another appropriate law enforcement agency about
3	that.	
4	And	if you tell the judge that you met with us, please understand that it may
5	prompt que	estions from the judge about what you said and whether it is consistent with
6	your prior s	tatements and acceptance of responsibility. And if the judge starts asking
7	questions, \	we may get asked to respond and divulge what you said.
8	And	just to note, logistically, if you need a break or you would like to discuss
9	something	with Ms. Fitzharris, just let us know; happy to accommodate that.
10	And	because is also on this call, there might be times when both of
11	us ask ques	tions at the same time, especially given the remote nature. So if that
12	happens, yo	ou know, just say you couldn't hear it, couldn't understand it, we'll stop, and I
13	will repeat	the question.
14	Doe	s that all make sense?
15	Mr.	<u>Herendeen.</u> Yes.
16		. Great.
17		EXAMINATION

19	Q	So we're going to jump into just a little bit of background to get started,
20	Mr. Herend	een. How old are you?
21	А	Forty-four.
22	Q	And where do you currently live?
23	А	Chesterfield, Michigan.
24	Q	How long have you lived there?
25	А	Going on 4 years.

1		Q	Great. What is your educational background?
2		Α	Some college.
3		Q	Okay. What do you do for a living?
4		Α	Construction.
5		Q	Okay. Do you have any other jobs from construction or is it just working on
6	jobs?		
7		Α	Well, I do union construction and I have an epoxy floor business.
8		Q	Oh, okay. So it's your own business?
9		Α	Yeah.
10		Q	Great. All right. So leading up to January 6th just in general, and just to
11	give yo	ou a s	ense of, like, where we are in time, I'm thinking 2016, so like Trump's election
12	up unt	il righ	at before the November 2020 election. And this is sort of an open-ended
13	questi	on bu	t, like, how politically engaged were you during that time?
14		Α	I was engaged, not at first really. I mean, I was engaged the whole time
15	throug	gh Fac	ebook basically. And it seemed like all the same people on Facebook were
16	engage	ed in	the same thing around the same time.
17		Q	So were you paying, like, close attention to politics, do you think?

A Never before till Trump ran. I didn't really care that much. And I don't know what made me care that much, really. It's -- but yeah. So before he was elected, I did go to hear him speak at Macomb Community College in Michigan [inaudible]. And that was the first I went. I didn't go to any other rallies. I watched stuff on Facebook, basically, is where I got it.

Q Right. But there was something about President Trump that made you want to be -- to follow politics or to pay more attention?

A Yeah. Well, he said the right stuff. You know, he was going to shape up

- the government, help middle-class Americans, you know. Basically, make it like he said,
- 2 Make America Great, and we bought into it.
- 3 Q Yeah. He had a message.
- 4 A Yeah.
- 5 Q And it was there.
- Do you remember -- so you just mentioned Facebook. Was that where you were getting most of your political news at the time or other --
- A Yeah, yeah. I mean, I would get it from Facebook and then look stuff up on the internet too. I wouldn't just go off Facebook. Yeah. But main source of it was coming through my Facebook feeds, I would say.
- 11 Q And how did that work? Was it friends posting or like organizations, like
  12 CNN would post something on Facebook and put it there?
- A Well, both really. FOX, CNN, friends. Yeah. I mean, there were groups that post. I wasn't really in any groups on Facebook, just -- yeah, just my news feed, what came across that.
- 16 Q Okay.
- A Basically, now that I look back at it, it was just -- I was getting one-sided feeds the whole time, you know. So --
- 19 Q Understood. Were you watching, like, television news at all during that 20 time?
- A Not that much, no.
- Q And these questions are really just to get a sense of like, you know, how people were consuming news at the time. So it's -- and not necessarily specific to you, but -- I'm sorry. It is specific to you, but I don't want you to think like -- we ask these of all people, so don't --

- Q Do you really, like, remember his messaging a lot, like paying attention to it
- 10 closely before the election?
- 11 A I have -- yeah. I was paying attention.
- 12 Q Yeah. So then, I guess, right around -- or right after, I should say, the
- November 2020 election, did you believe that the election was stolen from President
- 14 Trump?
- 15 A I did.
- 16 Q And so what made you believe that?
- 17 A Well, going back to that night, I was actually watching news channels and
- paying close attention. And then, you know, go to bed and there is a huge lead, and
- then wake up and it's gone. And all these coincidence happened at all these main cities
- at the same time, water main breaks, postal deliveries all around the same time. They
- just put stuff out there, make it -- I don't know if it's true or not, but it made it very
- 22 convincible that the election was stolen.
- 23 Q So do you remember where you were hearing those things?
- 24 A Facebook.
- Q Okay.

Different --1 Α 2 Q Was it --Outsource -- different people's putting different stuff out there. I don't -- I 3 4 couldn't tell you specifically where I heard from this. 5 No, no. That's fine. Q 6 Yeah. So let me try to -- you were paying attention on -- you were watching it on the news, and you were watching it on Facebook --7 8 Α Yeah. 9 Q -- and people were talking about these things? 10 Α Yes. 11 Q Okay. Was former President Trump talking about these issues too, and were you paying attention to those? 12 13 Α Yes. Q So is it fair to say that you almost right away, I guess, like when you woke up 14 the next morning, that you believed that the election was stolen? 15 Α Yes. 16 Q All right. And how did you feel about that? 17 Α I felt like, you know, just from what was out before the election, that 18 19 everyone kind of knew it was going to get tampered with. They were putting it out 20 there before the election. And then how it went down, I felt like it was stolen. But 21 then I question, well, why wouldn't something be done about it? Just -- so yeah. So I 22 thought it was stolen when I woke up the next morning, basically. 23 Q I understand. Do you remember seeing posts about the possibility of the

election being stolen --

11	things, also	had concerns about the elections, reinforced your views?
12	Α	Yes.
13	Q	Did you ever have conversations with them about what they were listening
14	to, watching	g, reading?
15	Α	Well, yeah. Well, basically, some of the sites you mentioned, Telegram,
16	you know, F	Facebook, Twitter, you know. My one buddy gets all of his information from
17	Twitter. Y	ou know, it just depends on what platform they prefer to use, I guess.
18	Q	And did you get the sense that sorry. In the time before the election
19	when you w	vere talking to your friends or your colleagues, did you get the sense that they
20	were hearin	ng this from President Trump, through social media, or from somewhere else?
21	Α	Probably President Trump and some other places too.
22	Q	Great. Thank you.
23	So I'	ll jump back to after the election now. So after the election, did you
24	participate i	in any activities related to election fraud following the election? So like a

rally or something?

1	Α	Just January 6th.
2	Q	Just January 6th. Okay.
3	Did	you make any political donations to groups that were arguing about election
4	fraud or ele	ction integrity between the election and January 6th?
5	А	No.
6	Q	All right. Well, let's talk about we'll get to January 6th basically. What
7	made you v	vant to go?
8	А	Well, President asked us to come. And I had just worked from before
9	Thanksgivin	g till right before Christmas in Alabama every single day. And so I got back
10	and though	t it'd be fun. I planned on, like, going and seeing the city and everything,
11	making a lit	tle trip out of it. I thought it would be a good time.
12	Q	So you mentioned that the President asked you. Do you remember a
13	specific me	ssage that he said?
14	А	Basically, he asked for us to come to D.C. Big things are going to happen.
15	And so yeal	n. So I went for that. And like I said, I planned on making a little trip out of

- Right. Do you remember a tweet from like December 19th where he asked 18 people to come and said it would be a wild protest?
- 19 Α I don't remember it in that words, but asking people to come, that there'd 20 be a big unveiling.
- Q 21 Yes.

- 22 Α Something along those lines. You know, you don't want to miss it, basically. 23
- Yeah. Do you remember like what date you decided to go to D.C.? 24 Q
- Α No. Well, we didn't actually even -- even the day we were supposed to go, 25

1	I didn't talk to Bobby till later on in the morning. So I didn't even know the day we were
2	going to go if we were still going or not. But it was a couple of days probably before
3	Christmas I started asking buddies if they wanted to go.
4	Q Did you have a lot of friends who were going to go, besides Mr. Schornack?
5	A Well, we had our buddy Cliff who was the Tennessee sheriff, I knew he was
6	going, and we met him there. But I had my two best friends, they backed out at the
7	last minute, so that's why I went to Bobby.
8	Q All right. Did your best friends give you a reason why they backed out?
9	A No. No. Just busy lives. I just like I said, I had just worked. I had

11 Q You needed a vacation?

- Q So you mentioned Bobby. Is that Bobby Schornack, just for the record?
- 14 A Yes.
- 15 Q And did you drive up with him or with him and Cliff or just with him?
- 16 A No. Me and Bobby drove to D.C. and met Cliff there.
- 17 Q Okay.
- 18 A I picked Bobby up from his house and drove us to D.C.
- 19 Q Do you remember what date that was?
- A January 5th.
  - Q Okay. So in between the time that you decided to go and the time that you left, so let's say like late December, January 5th, were you paying attention to social media to learn about what would happen on January 6th?
- A Yeah. Yeah. Was watching it and they said it's probably going to be hard to get into D.C. with all the people. And blah, blah, blah. And places to stay would be

- limited, and -- but, you know, people just kept promising big things. It was not only
- 2 Trump, but other people on social media.
- 3 Q Do you remember any of those -- who those people were? Were they
- 4 like -- sorry. Were they, you know, elected officials or were they just kind of people you
- 5 followed?
- 6 A Probably just people I followed. I wouldn't say elected officials. Maybe
- 7 like someone in Trump's camp or something like that would tweet something that would
- 8 make its way to Facebook, and --
- 9 Q Do you remember any specific, like, groups or organizations that were giving
- information about January 6th?
- A Like, Stop the Steal. There was a Stop the Steal group on Facebook, I think.
- There was a few groups like that that just would come across my news feed even though I
- wasn't in them, you know.
- 14 Q All right. So you were just sort of following what's going on and you had a
- sense of what was happening.
- Did you ever, like, post about January 6th and say, hey, we should all go, try to get
- other people besides your close group of friends to go?
- 18 A I don't -- I don't think I posted anything just out there for the world, like, hey,
- let's all go. I think I just said, hey, let's -- to my buddies, let's go. Let's make a trip out
- of it. And communicated with them the next few days. So they said, no, can't go.
- 21 And then, basically, I said, Bobby, let's go.
- 22 Q Thank you. On Facebook or whatever, did you hear talk about buses,
- caravans, stuff like that, traveling?
- A We -- I did. We -- what I heard is they were going to bus in
- counter-protesters by the busloads. And that was another thing we were seeing before,

- that the counter-protesters are going to be attacking Trump supporters and people that
- went for the rally, and -- so, I mean, people -- like, the friends that didn't go, they were
- worried a little bit, wanted to make sure I was safe and protected.
- 4 Q So you were worried about violence?
- 5 A Yes.
- Q Was there any reason besides these posts about the floods of
- 7 counter-protesters that you were worried about violence?
- A Well, I mean, anytime you got that many people coming together, I mean, there's always a worry of something happening, a bomb, whatever. You know, who
- 10 knows. But, yeah, I was a little nervous going. I was a little nervous being there even.
- You know, you see snipers on the buildings and stuff, and scaffolding down by the Capitol,
- and turn around there's people everywhere. And so, I mean -- it was -- it wasn't like the
- greatest time being there. I mean, I was -- I enjoyed it, but I was nervous the whole time
- 14 too and --
- 15 Q So is it the -- back to the counter-protesters, what about them were you
- 16 worried about?
- A Well, we'd see stuff like them attacking at other cities in marches or parades
- or rallies or whatever. They -- I mean, they would come across on news feed and you'd
- see old people with bloody noses and they would blame it on antifa or something. They
- 20 made it really seem like there was a good possibility that, like, be attacked by
- 21 counter-protesters.
- 22 Q Was antifa like a big topic on Facebook as well --
- 23 A Oh, yes.
- 24 Q -- in the time before?
- 25 A Yes.

1 So was that something that you'd see a lot of videos and you were -- you felt Q 2 was a threat to the country? Α Yes. 3 All right. And is that why you -- did you bring anything with you to prepare 4 Q for the violence? 5 Yes. I brought --6 7 Q What did ---- a can of bear spray, a bulletproof vest, goggles. 8 9 [Witness conferring with counsel.] The Reporter. Is this off the record? 10 Do you two want a second? 11 Mr. <u>Herendeen.</u> No. No. I'm sorry. 12 Ms. Fitzharris. Can you give us a few seconds? 13 Yeah. We'll go off the record for a second, at 2:24 p.m. 14 [Discussion off the record.] 15 BY 16 I just asked how did you prepare. 17 Q Α Okay. 18 19 Q Yeah. 20 So it was bear spray, bulletproof vest --I'm sorry. I just want to make sure we're on the record. Are 21 we back on the record? 22 23 The Reporter. We are on. Okay. Thank you. 24 Thank you. 25

2	Q Go ahead, Mr. Herendeen.
3	A Okay. Bear spray, bulletproof vest. I did buy knives along with the bear
4	spray, but I did not bring those. I made sure everything I bought was legal to have in the
5	State of D.C or the District of D.C. I might have gloves, and first aid kit, water.
6	Q Okay.
7	A That's about it, I think.
8	Q Thank you. And just I'm going to back up a little bit in thinking about the
9	threat of antifa. Was there a lot of activity in Michigan about antifa or other protests
10	over the course of 2020?
11	A Not so much Michigan. I mean, there was a kind of storming of the
12	Michigan capitol, I guess it would be, but was it illegal? I guess they were allowed to be
13	in I don't know. But that's the only kind of thing I seen in Michigan was what
14	happened at the State capitol. Like Oregon, I think there was a march in D.C. where it
15	happened. I know someone was stabbed in Oregon. I mean, I really don't know,
16	because who knows what's real out there anymore. So
17	Q You saw it? You saw it?
18	A Yeah. I saw it.
19	Q So in terms of Michigan, you mentioned the storming of the capitol. I take
20	it from your answer you weren't there?
21	A No.
22	Q Okay. Did you know anybody who went?
23	A No.
24	Q Okay. Do you know any, like, militia groups in Michigan?
25	A I mean, there everyone knows the Michigan militia, I mean. But, no, I

- don't know anyone in it or involved in it, but everybody knows about them.
- 2 Q Okay. When you said everyone knows, you meant just like in general
- 3 everyone knows about them?
- 4 A Yeah.
- 5 Q Okay. Thank you. We'll head back to Washington, D.C. in the next
- 6 question.
- 7 Do you remember where you stayed in the area?
- 8 A It was probably 15 minutes from the Memorial. I don't -- I mean, I could
- 9 look at my credit card statement and find out the hotel. It was a decent, nice hotel.
- 10 It's where [inaudible] stage.
- 11 Q Okav.
- 12 A We didn't even have a reservation, that's how planned we were. We just
- showed up and luckily got a room.
- 14 Q And that was in the District?
- 15 A Yes.
- 16 Q All right. Okay. So I think you mentioned a knife. Did you end up
- bringing that to the hotel or did you leave that at home?
- 18 A No, I left it at home in Michigan.
- 19 Q All right. So what time did you arrive January 5th?
- A It might have been actually January 6th by the time we arrived. It was late,
- 21 midnight on to somewhere around there.
- 22 Q And you didn't see any activities that had happened on January 5th then?
- 23 A No.
- 24 Q Yeah. Okay. So what time did you end up going to the Ellipse for the rally
- on the morning of January 6th?

1 Α Morning, 9:30, 10, 10:30, somewhere around there. I mean --2 Q Were you there just to hear President Trump speak or were you excited to hear anybody else? 3 4 Well, I was excited because I was told, you know, we're going to tell you guys 5 this, tell you guys that, you know, big unveiling, unveiling. But, no, I mean, to be honest, I was -- after he spoke, I was -- it was just the same thing he's been saying. There was 6 nothing new, so -- so, yeah, I was kind of disappointed in the speech actually. So there 7 8 was nothing new, nothing exciting. 9 Q Okay. So you were -- you went hoping to hear some -- were you hoping to 10 hear evidence about --Α Yeah. 11 Q -- the election --12 13 Α Yeah. Q Okay. And you --14 15 The Reporter. One at a time, please. Sorry about that. 16 BY 17 So let me reask the question. Were you expecting to hear evidence about 18 Q 19 the election being stolen from President Trump? 20 Α Yes. Q 21 And were you -- when you listened to the speech, did you hear anything 22 new? 23 Α No. Can you tell me like what the mood in the crowd was at that time? 24 Q 25 Α I mean, patriotic I guess you'd call it. They were pretty calm. There was a

- lot of chanting USA. The crowd was pretty calm. I mean, some -- I don't know, it was a
- weird crowd. There was some people that looked like they were -- that sounded like
- they were yelling "fuck Trump" in the background. Sorry for my language, but that's
- 4 what they were saying. And then there were these like Chinese nationals there trying to
- 5 get people to sign all this stuff. Then I seen a couple of Oath Keepers. You know, a
- 6 variety of people, you know.
- 7 Q All right. Did you engage with the Oath Keepers or anybody?
- 8 A No. I just stuck with basically Bobby, Cliff, and Cliff's friend that he
- brought, the other sheriff. Basically stayed in the same area the whole time.
- 10 Q Did you talk to anybody else about your disappointment in President
- 11 Trump's speech while it was happening?

2	Α	Yeah.	I'm pretty sure I talked to Bobby about it; like, this is the same
3	speech we'v	/e been l	istening to the last 2 months, 3 months, you know.
4	Q	Yeah.	Do you recall President Trump saying anything about Vice President

Did January 6th, the date, mean anything specific to you when you went?

- 1 A Not specific to me, no.
- 2 Q Okay. So were you aware that Congress was certifying the electoral count
- 3 that day?
- 4 A I was aware of that, yes.
- 5 Q And did you think that President Trump's reveal would in some way stop
- 6 that count?
- 7 A I didn't know if it would stop it or show proof that they should stop it. Like,
- 8 that's what I was -- I thought there was going to be some type of proof, evidence that it
- 9 was going to get put in there and things that happens, which --
- 10 Q So did you hope that, with the evidence, maybe Vice President Pence would
- stop the electoral certification?
- 12 A Yeah. Well, I was hoping it'd get stopped. I didn't know really who would
- stop it. I didn't know exact -- I don't know exactly how it goes. I was just hoping it'd
- 14 get stopped.
- 15 Q And was that like a message going on in the crowd, you know, like, we're
- here to stop the certification or --
- 17 A Well, we were there to make our voices heard.
- 18 Q Right. Sorry. I used poor phrasing. Were people in the crowd sharing
- 19 your hope that there would be something that stopped the certification?
- 20 A Yes. I would say so, yes.
- 21 Q Okay. Do you remember -- did you listen to President Trump's whole
- speech or did you leave early?
- A I -- we listened to the whole speech. We started looking for a bathroom
- and heading, like, maybe couple minutes before he was finally done, but we still listened
- to the whole thing. We were still in earshot.

- 2 Q Gotcha. And while you're walking, are you checking social media, like
- 3 Facebook, at all? Are you just going?
- 4 A No. We were pretty much going. The phones kind of stopped working.
- You know, like being at a big sporting event or something, they just didn't work. They
- 6 worked when they wanted to or when you could get through.
- 7 Q Right. What was going on in the crowd as they were marching? Was it
- 8 the same as at the rally or had things changed?
- 9 A Kind of the same. I mean, you had your louder groups of people as you're
- walking. I think some stopped in front of the FBI building maybe, I don't know, some
- building, they were yelling at them or chanting at them. So, yeah, I just walked down
- 12 Congress. There was people chanting, people with flags, people with banners.
- Nothing that I would think would escalate real quickly with the area I was walking down.
- 14 Q Did you hear anybody saying things, like, hang Mike Pence?
- 15 A I did hear that when I got, like, by the Capitol.
- 16 Q And as you're walking up to the Capitol, what do you see? Just give me a
- 17 quick --
- 18 A I'm seeing it's getting more crowded. Like I said, I walked down Congress.
- 19 I finally met people from Michigan. We just talked to people like, you know, normal,
- 20 just walking. And we get there, and there was -- there was these kids that were going
- through the crowd antagonizing, saying, Pence screwed you. Pence screwed us. And
- then I watched these kids go through and saying that to crowds as I'm walking up. And
- then me and Bobby got separated, and that's when we got like to the Capitol steps, and
- that's -- people were getting louder.
- 25 Q So --

1	А	People were throwing stuff.	I don't know what	they were throwing it at,
2	because I co	ouldn't see the top of the steps	from where I was.	Me and Bobby got
3	separated,	so I was kind of looking around	for Bobby.	

Q Did you see police?

A I didn't see one cop from my walk from Congress, besides like on the side of the streets. All the way up walking to the Capitol doors I didn't see one cop.

Q Did you see any tear gas, any fences down, any --

A I heard -- I heard tear gas. I didn't really see it. I didn't see any barricades or fences, unless they were moved somewhere else by the time I got there. But it was very easy for me to walk up to the Capitol.

Q So while you're doing this, is there a reason that you were walking up to the Capitol?

A Well, we were trying to get close. We went there, as you know, like I said, to make our voices heard, be loud and all. And then I got separated from Bobby, and looked for Bobby basically at the foot of the steps for a while, and then walked up the steps. I mean, he had a red hat on, I kept thinking I'd see him, so I walked this way, walked that way. And then I was at the door of the Capitol.

Q And what was going on while you were at the door of the Capitol?

A Well, I was video recording, so I was just watching people walk in. I video recorded the windows were broke, but the doors were wide open. People were just walking right in like -- I don't know. People were just walking in. There wasn't anyone stopping them, telling them not to come in or anything. I don't know if that all happened right before I got to that point or -- I didn't see a police officer till I walked in, turned right, and almost till I got to the Crypt is when I seen my first police officer.

Q Do you remember what time you walked in?

- 1 A 2:20.
- Q 2:20? So it was pretty soon after the first people got in. I'll represent to you that the first people got in around like 2:15 on the Senate side. Did you happen to
- 4 see that happen? Did you see the first people get in?
- 5 A No, I didn't.
- 6 Q But were you seeing people pushing cops or barriers at all on your way up?
- 7 A No.

- 8 Q No shouting?
- A I mean, there was shouting. There were people throwing stuff, like I said.

  But I didn't see any cops blocking people. But I couldn't see on the top. There were

  people already up there. I couldn't see up there from where I was, so -- I went over on

  the -- there was this little hill, I looked out for Bobby, then I went by the steps and started

making my way up the steps looking for him.

- Q Was there anyone that you noticed encouraging people to go into the Capitol?
- A There were people encouraging. Yeah, there was chants of "push forward" and stuff. But this was before I got to the Capitol. This is the big crowd at the bottom of the steps, making different ways up the steps.
  - Q All right. So if you're hearing "push forward" and people encouraging, did you get the sense that there was something that was trying to stop all these people from getting up to the Capitol?
  - A Yeah. Well, I guess, but it's -- it's -- I didn't know if they were pushing each other forward, but people were getting to the top and just walking. I could see them walk by the wall up top; I just couldn't see the top of the stairs. Yeah. I didn't know how close you could get to it really. I was looking for Bobby and, I don't know, it was

- kind of like a car crash, you want to see it but you don't want to get in it. And I got in it.
- Q So you did -- at the time, you thought it was kind of like a car crash, or is this
  your thinking --
  - A Yeah. Well, no. Well, I'm thinking I want to get as close as I can, I want to see what's going on. And I've got to find Bobby and this is the way Bobby was headed, so that is the way I headed. And like I said, I didn't have a problem with the crowd. I walked right up the steps. There was a group of -- like a line of people, just walked up the steps, turned left, and when we got there, it opens up. And I actually took time, opened my backpack up, put my coat in there, took some video, and then went by the door and seen the glass broken, took video, looked in, and then I walked in. That was my mistake right there is walking in.
- 12 Q What did you think when you saw the broken glass?
- 13 A I thought people were assholes. I have video of like me, when I'm in there,
  14 saying don't break anything, you know. Yeah. I wasn't there to trash a building and
  15 that stuff.
- 16 Q So why did you go in?

7	n't get in there. I was just on the outskirts basically the whole time. And, you		
8	know, there was people that wanted something to happen, you could tell for sure. And		
9	then there's people that were just taking pictures and roaming around.		
10	Q And did you get a sense of what they wanted to happen?		
11	A The sense was they wanted to stop whatever was happening there, whi	ch,	
12	you know I can't speak for them. I don't know what they wanted, but my sense is they		
13	wanted to do something about what was going on.

- 4 Q Did you take any pictures while you were inside?
- 5 A I took videos, yes.
  - Q So I think, and you can correct me if I'm wrong, but I was looking at your statement of facts that was filed with your case in the docket, and there might be a selfie that you took in there with a friend in the Capitol. Is that true?

3	Ms. Fitzharris. Mr. Herendeen pleaded guilty with a plea agreement to a class A

25	A But, I mean, look, as I said, I've dealt with it now, and I just don't want		

1 anything to do with it on either side. 2 Do you still think the election was stolen from former President Trump? Q Α I don't care. 3 Q You don't care, but -- so you just --4 Α I don't care. 5 Haven't given it a thought? 6 Q Α No. 7 Q Okay. And you mentioned feeling a little betrayed by President Trump. 8 9 Have your feelings about him changed? 10 Α Yeah. Like I said, I don't follow him. I don't care what he has to say. I 11 don't, you know -- I mean, I don't even know how I got involved in it in the first place, but --12 13 Q Yeah. Α But it was a ride I didn't like when I got off it. 14 15 Q As you said, it left sort of a black mark in your mind both about the day and maybe it sounds like, and please tell me if I'm wrong, a black mark about politics in 16 general for you? 17 Α Yes. 18 19 Q This is sort of a question we ask a lot of people. If you don't have 20 an answer, totally fine. But do you think there's anything that could have been done 21 differently to prevent a situation like January 6th from happening? 22 Α More security. From when there was a million people in D.C. and you 23 know what they're there for, more security. Okay. Well, thank you Mr. Herendeen. We've covered a bunch of topics 24 Q

today. Is there anything else that you wanted to let us know before we --

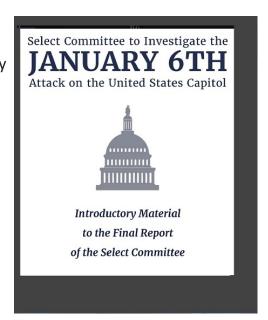
